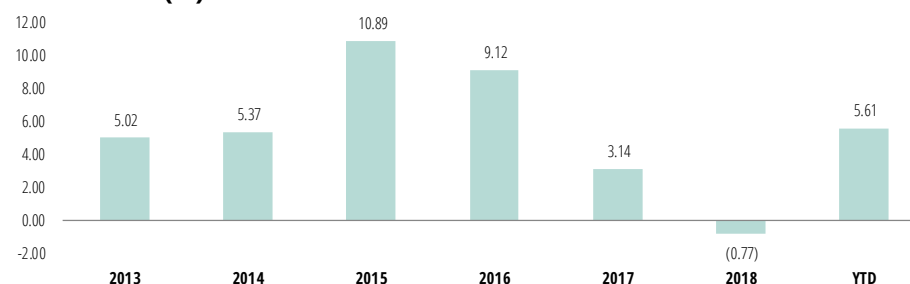

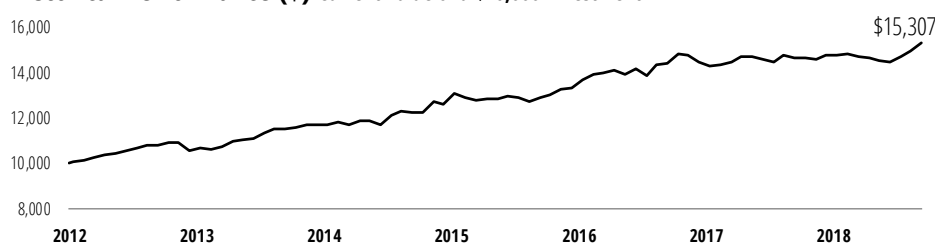

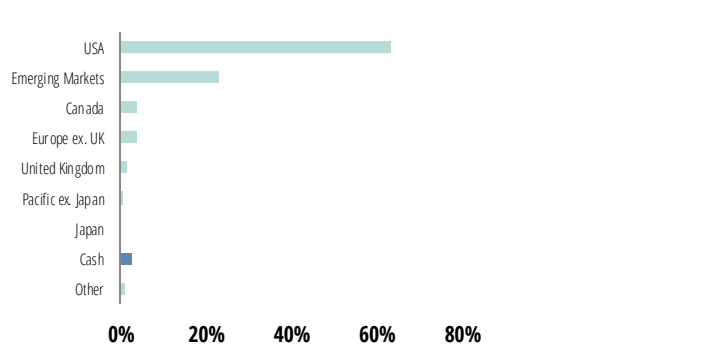
## Performance (%) Calendar Year Returns



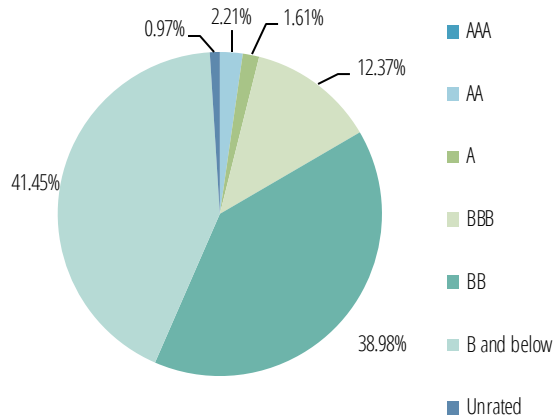
## Historical Performance (\$) Current Value of a \$10,000 Investment



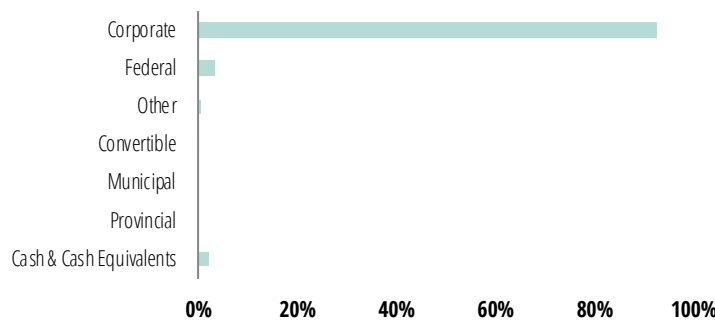
## Effective Regional Allocation



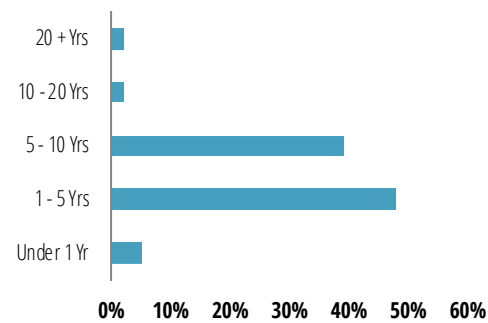
