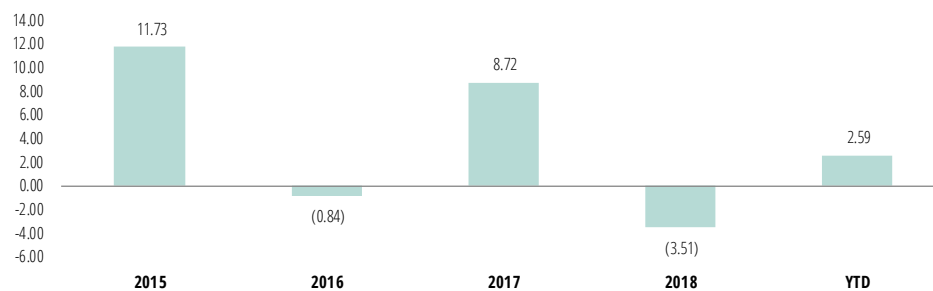

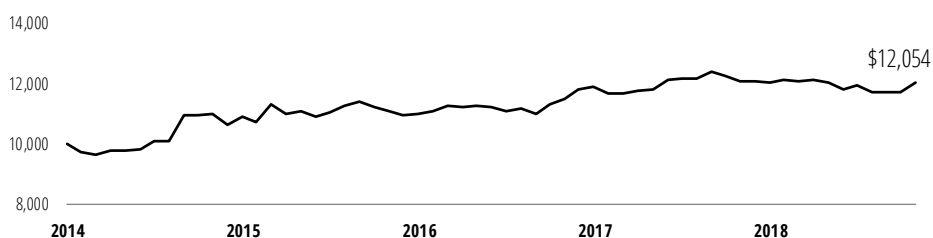

### Performance (%) Calendar Year Returns



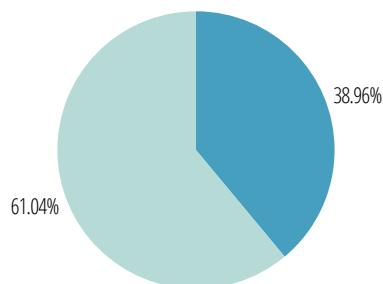
### Historical Performance (\$) Current Value of a \$10,000 Investment



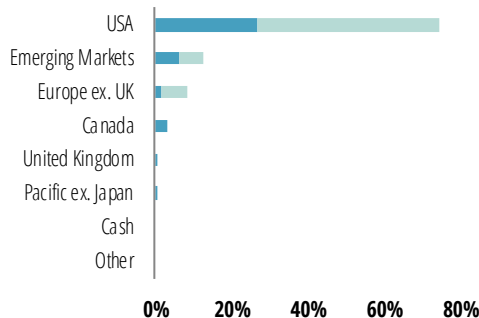

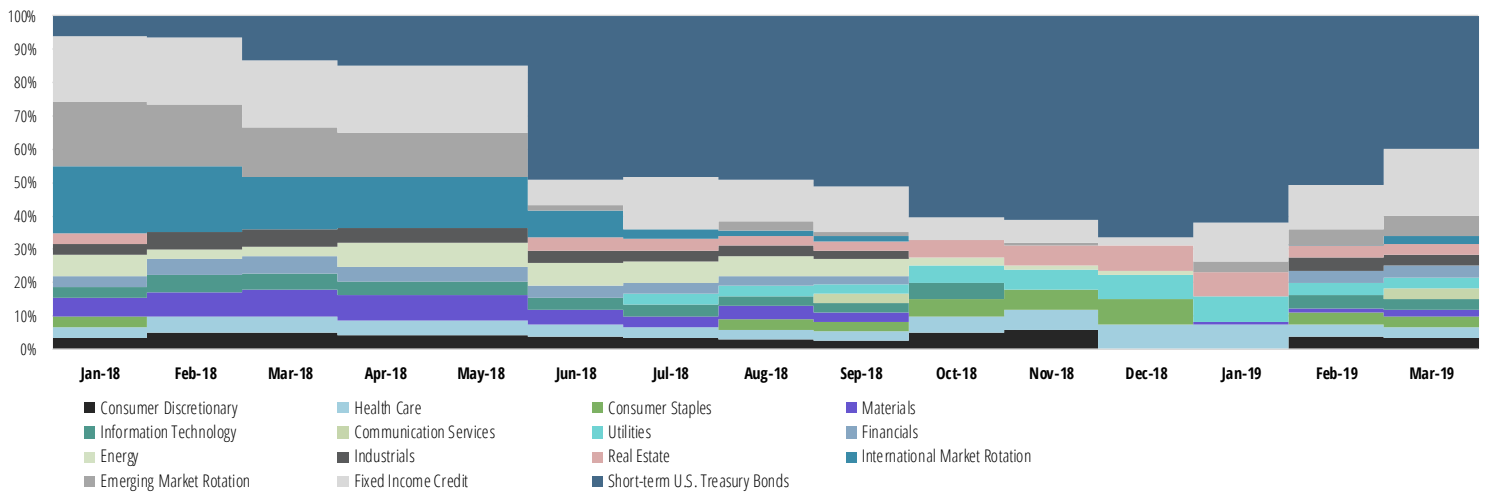
## Effective Currency Exposure
