# Management Discussion of Fund Performance

November 13, 2018

This Interim Management Report of Fund Performance is intended to present the significant factors and developments that have affected the Fund's performance and outlook since March 31, 2018, the Fund's last fiscal year-end. For information on the Fund's longer-term performance, please refer to the *Past Performance* section of the report. In this report, "Counsel" refers to Counsel Portfolio Services Inc., the manager of the Fund.

In addition, net asset value (NAV) refers to the value of the Fund or a series as calculated for transaction purposes, on which the discussion of Fund performance is based.

The Fund is not available to retail investors and is only available to other institutional investors (primarily other Counsel Funds).

## Results of Operations

### Investment Performance

The performance of the Fund's Series O securities is discussed below. The performance of all other series offered by the Fund is shown in the *Past Performance* section of this report. Series returns may differ for a number of reasons, including if the series was not issued and outstanding for the entire reporting period and because of different levels of fees and expenses charged to each series. Please refer to the *Series Information* section of this report for the varying management and administration fees payable by each series.

During the six-month period, the Fund's Series O securities returned 6.78%. This compares with a 7.08% return of the MSCI World Index (the "Index"). All index and series returns are calculated on a total return basis in Canadian dollar terms.

The sub-advisor employs a multi-factor quantitative investment signal, which weighs momentum, valuation, and macroeconomic factors to determine the Fund's investment level in global equity markets versus cash. The quantitative signal moves on a daily/weekly/monthly basis which triggers adjustments to the allocation between equities and cash, which can vary between 100% equities or 100% cash.

The Fund's equity position was 95% at the beginning of April 2018, after which the Fund's signal increased, bringing the equity weight back to 100% by the end of April 2018 where it remained for the duration of the period. Even though the signal was declining throughout the period, it didn't drop below zero. Although the Fund was fully invested in equities throughout majority of the period, the reduced equity exposure in April provided downside protection as global equity markets fell. This came at the cost of

some of the relative upside as equity markets quickly recovered, causing slight underperformance relative to the index. The level of the Fund's investment signal ended the period at 0.34, as all contributing factors were declining, driven by diminishing momentum, moderate weakening in earnings revisions and increasing Energy prices and rising bond yields.

The Fund's was unhedged against the U.S. Dollar ("USD") throughout the period. During the six-month period, the USD appreciated 0.32% against the Canadian Dollar ("CAD"). As a result, the Fund's USD exposure contributed to the Fund's performance.

The Fund was unhedged against international currencies, other than the USD. During the period, the CAD appreciated by 5.56% against a broad basket of international currencies, as weighted in the MSCI EAFE index. As a result, the Fund's foreign currency exposure had a negative impact on performance.

### Net Assets

The Fund's NAV increased by \$25.2 million, or 25.8%, to \$123.0 million as at September 30, 2018, from \$97.8 million at March 31, 2018. Of this increase, \$18.0 million was attributable to net sales and \$7.2 million due to investment performance (after deducting fees and expenses).

Certain other Counsel Funds ("Top Funds") managed by Counsel's affiliates have large investments in the Fund, see *Other Related Party Transactions* for details. As a result of these investments, the Fund is subject to large transaction risk as discussed in the Simplified Prospectus. Counsel manages this risk to reduce the possibility of any adverse effect on the value of the Fund or on its investors, through such processes as requiring advance notice of large redemptions.

### Fees and Expenses

The Management Expense Ratio ("MER") for Series O of 0.01%, during the period ended September 30, 2018, was unchanged from the year ended March 31, 2018. No expenses (including management or administration fees) are charged to Series O, other than certain specific fund costs (primarily interest). The MER primarily represents the Fund's proportionate share of expenses in underlying investment funds. The MERs (before and after waivers or absorptions, if any) are presented in the *Financial Highlights* section of this report.

## Recent Developments

Global equity markets showed synchronized growth early in the period, but that has subsided by the end of the period on trade concerns with a new round of tariffs between the US and China. Positive U.S. economic data and improved sentiment in Japan have supported equities. Eurozone sovereign bonds fell as global bond yields rose on rising signs of wage inflation while Italian spreads, although down slightly in September, rose at month-end on disappointing developments on the Italian budget proposals for 2019.

The main risk is concern around global trade. Global growth could be threatened if the recent spate of tariff announcements continues, and the measures announced (and possibly more tariffs) are actually implemented. In such a scenario, current global growth and earnings expectations would prove to be too optimistic and equity valuation multiples would probably decline, leading to falls in equity markets. Ultimately, the sub-advisor believes the well-known costs associated with a global trade war will prevent this happening. Recent success in the USMCA trade negotiations, and the agreement between the U.S. and Japan to enter bilateral trade talks, for example, suggest a worst-case trade outcome can be avoided. An additional risk is the ongoing reduction of policy accommodation by global central banks. A withdrawal of accommodative policy has been well flagged and should not be a surprise to investors. It is occurring because global growth has improved to the point where the level of policy accommodation provided since the financial crisis is no longer required. We believe the positive growth backdrop will offset any negative impact on equity markets from reduced levels of policy accommodation.

In early October, based on a trigger from the valuation input, the Fund's investment signal crossed into negative territory and the Fund reduced its equity position to 70%. The Fund is expected to remain generally unhedged against currencies other than the USD for the foreseeable future.

## Related Party Transactions

### Management and Administration Services

Top Funds represent nearly all of the Fund's investors. As a result, Counsel pays all costs and expenses (other than certain specified fund costs) required to operate the Fund. No management or administration fees are paid by the Fund.

## Other Related Party Transactions

Other investment funds managed by Counsel (“Top Funds”) invest in Series O securities offered by the Fund on a prospectus-exempt basis in accordance with the investment objectives of those funds. At September 30, 2018, Top Funds owned nearly 100% of the Fund’s NAV. As of September 30, 2018, Counsel had not received notice of any large redemptions. All related party transactions are based on the NAV per security on each transaction day.

Counsel is a subsidiary of IGM Financial Inc. (“IGM”). IGM is a subsidiary of Power Financial Corporation, which in turn is a subsidiary of Power Corporation of Canada. Companies related to Power Corporation of Canada are therefore considered affiliates of Counsel. As at September 30, 2018, the Fund held the following investments in companies affiliated with the Manager: subordinated voting shares of Power Corporation of Canada valued at \$0.01 million, common shares of Power Financial Corporation valued at \$0.01 million, and common shares of Great-West Lifeco Inc. valued at \$0.01 million. These investments are in accordance with policies approved by the Counsel Funds’ Independent Review Committee (“IRC”) and represent, in aggregate, less than 0.1% of the Fund’s net assets. The IRC approved these policies on the basis that these investments would:

(i) is made free from any influence by an entity related to Counsel and without taking into account any considerations relevant to an entity related to Counsel;

(ii) represents the business judgment of Counsel, uninfluenced by considerations other than the best interests of the Fund;

(iii) made as part of a strategy where the value of such an investment is determined based on its relative weighting in an index; and

(iv) achieves a fair and reasonable result for the Fund.

## Series Information

The Fund may issue an unlimited number of securities for each series. The number of issued and outstanding securities of each series is disclosed in *Financial Highlights*. 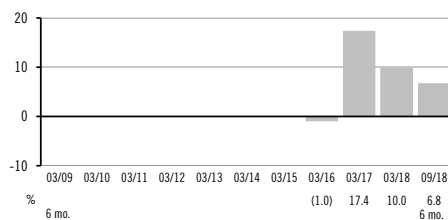

## Year-by-Year Returns

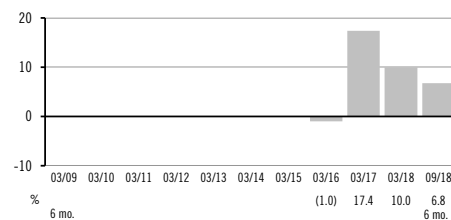
The bar chart shows how much an investment made on the first day of each financial year would have increased or decreased by the end of the respective periods. For the first year of a series, the percentage

<sup>7</sup> The portfolio turnover rate ("PTR") indicates how actively the portfolio advisor manages the investments. A PTR of 100% is equivalent to the Fund buying and selling all of the securities in its portfolio once in the course of the period. The higher PTR in a period, the greater the trading costs payable by the Fund in the period, and the greater the chance of an investor receiving taxable capital gains in the period. There is not necessarily a relationship between a high PTR and the performance of the Fund. Costs incurred to realign the Fund's portfolio after a fund merger, if any, are excluded from the PTR.
