Management Discussion of Fund Performance

November 13, 2018

This Interim Management Report of Fund Performance is intended to present the significant factors and developments that have affected the Fund's performance and outlook since March 31, 2018, the Fund's last fiscal year-end. For information on the Fund's longer-term performance, please refer to the *Past Performance* section of the report. In this report, "Counsel" refers to Counsel Portfolio Services Inc., the manager of the Fund.

In addition, net asset value (NAV) refers to the value of the Fund or a series as calculated for transaction purposes, on which the discussion of Fund performance is based.

Results of Operations

Investment Performance

The performance of the Fund's Series A securities is discussed below. The performance of all other series offered by the Fund is shown in the *Past Performance* section of this report. Series returns may differ for a number of reasons, including if the series was not issued and outstanding for the entire reporting period and because of different levels of fees and expenses charged to each series. Please refer to the *Series Information* section of this report for the varying management and administration fees payable by series.

During the six-month period, the Fund's Series A securities returned -0.71% (after deducting fees and expenses). This compares with a 5.56% return for a blended benchmark comprised of 70% MSCI World NR Index (returned 7.08%), 20% BofAML US HY Master II TR Index (returned 3.73%), and 10% S&P GSCI TR Index (returned 9.73%) (the "Blended Benchmark"). All index and series returns are calculated on a total return basis in Canadian dollar terms. Investors cannot invest in an index without incurring fees, expenses and commissions, none of which are reflected in the index returns.

The Fund underperformed the broad-based MSCI World Total Return Index. The broad-based index is comprised solely of global equities, whereas the Fund invests in equities, commodities, and credit instruments. Given the Fund's composition, the Blended Benchmark provides a more meaningful comparison.

The Fund underperformed the Blended Benchmark primarily due to a high allocation to the Canadian Energy sector, wheat prices, and emerging market debt during the period. The sub-advisor increased the Fund's allocation to its safety bucket of U.S. Treasuries as markets became more volatile through the third quarter of 2018. The Fund has largely remained invested in U.S. equities, where momentum had been strongest. Deteriorating price

momentum in non-U.S. equity markets has been the driver of position reduction and re-allocations to the safety bucket. Generally, these have occurred after reasonably long periods of upwards moves in which the Fund participated. The reductions could be broken down further between local equity market returns and currency returns, as the second half of Q2 saw some U.S. dollar ("USD") strength. There are several factors that the sub-advisor believes are driving this, including global trade fears (particularly the near uniform sell-off in Asian emerging markets in late June) and steadily rising interest rates

Between April 1, 2018 and June 6, 2018, the Fund's target hedge against the U.S. Dollar ("USD") ranged from 25% to 50%. The hedge was removed on June 6, 2018. During the six-month period, the USD appreciated 0.32% against the Canadian Dollar ("CAD"). As a result, the currency hedge detracted from the Fund's performance.

Net Assets

The Fund's NAV increased by \$64.8 million, or 16.5%, to \$458.3 million as at September 30, 2018, from \$393.5 million at March 31, 2018. Of this increase, \$63.4 million was attributable to net sales and \$1.4 million due to investment performance (after deducting fees and expenses).

Certain other Counsel Funds ("Top Funds") and/or investment products managed by Counsel's affiliates have large investments in the Fund, see *Other Related Party Transactions* for details. As a result of these investments, the Fund is subject to large transaction risk as discussed in the Simplified Prospectus. Counsel manages this risk to reduce the possibility of any adverse effect on the value of the Fund or on its investors, through such processes as requiring advance notice of large redemptions.

Fees and Expenses

The Management Expense Ratio ("MER") for Series A of 2.73%, during the period ended September 30, 2018, was lower than the MER of 2.80% for the year ended March 31, 2018. The MER decreased due to changes in exchange traded funds held by the Fund. The MERs (before and after waivers or absorptions, if any) are presented in the *Financial Highlights* section of this report.

Recent Developments

Mount Lucas, the Fund's sub-advisor, believes that capital markets are becoming bifurcated. The Chairman of the U.S. Federal Reserve (the "Fed") has just described the U.S. economy as 'extraordinary'. Manufacturing and service sector surveys remain strong, holding at high levels for the past few months even as trade rhetoric and tariff action have risen. A large corporate tax cut and reform package coupled with a personal tax reduction have been attributed to this strength. U.S. stocks remain solid, ending the quarter at record highs. Sales growth now tops 9% year over year, doubling the 4% rate the current economic expansion has been generating. Current expectations for Q4 2018

earnings are approximately 25% over 2017. However, the picture remains less rosy overseas. European equity markets still trade below 2007 levels. Emerging markets have been hit hard as rising U.S. interest rates, weakening currencies, harsh trade rhetoric, and a series of political problems have come together to form a tough landscape.

The Fund's current composition reflects this bifurcation. It remains largely constructive on North American markets, having participated in the rally. It has little exposure to developed overseas or emerging markets. Credit markets and commodity markets are mixed in exposures, commodities having participated in the energy rebound. Short-term treasury bonds, where the Fund invests retreats when momentum is weak elsewhere, now generate higher yields than the past few years. The 2-year U.S. Treasury yield is up 1% over the past year and 0.5% higher now than where the 10-year U.S. Treasury was a year ago. The days of near zero yielding treasury securities are behind us and these now earn nearly 3%.

It will be difficult to forecast markets going forward. U.S. data remains solid. Mount Lucas's view is that the economy can withstand higher interest rates at this point. Monetary policy conditions remain supportive and real rates are not historically high. They believe there is still room for the Fed to restrict interest rates. Equity markets may have to contend with rising U.S. interest rates, as well as the possibility of ratcheting trade threats. How the politics of all of this plays out is also important. The bifurcation could go on for some time, or the politics could turn – both overseas and in North America. Having a quantitative mechanism to reduce risk in the U.S. if things slow or the politics change is certainly prudent. Similarly, having a systematic way to rebuild exposures in developed and emerging overseas markets should also be valuable. It is often easy to find reasons to sell out of the market; the discipline to buy back is often harder.

Subsequent to the end of the period, the Fund re-introduced its target hedge against the USD gradually increasing it to 95%. The USD hedge is dynamic and may vary between 0-100% at Counsel's discretion based on its assessment of currency market conditions.

Related Party Transactions

Management and Administration Services

For each applicable series, the Fund paid management fees and administration fees to Counsel at the annual rates specified under *Series Information* in this report and as more fully described in the Simplified Prospectus. In return for the administration fees, Counsel pays all costs and expenses (other than certain specified fund costs) required to operate the Fund. See also *Management Fees*.

Other Related Party Transactions

Other investment funds managed by Counsel (“Top Funds”) invest in Series O securities offered by the Fund on a prospectus-exempt basis in accordance with the investment objectives of those funds. Series Private Wealth securities are issued on a prospectus-exempt basis to investors in the IPC Private Wealth program offered by IPC Securities Corporation, an affiliate of Counsel. At September 30, 2018, Top Funds owned 73.9% of the Fund’s NAV and Series Private Wealth investors owned 18.5% of the Fund’s NAV. As of September 30, 2018, Counsel had not received notice of any large redemptions. All related party transactions are based on the NAV per security on each transaction day.

The Fund did not rely on an approval, positive recommendation, or standing instruction from the Counsel Funds’ Independent Review Committee (“IRC”) with respect to any related party transactions.

Management Fees

The Fund’s management fees were used by the Manager to pay for: costs of managing the investment portfolio; providing investment analysis and recommendations; making investment decisions; the purchase and sale of the investment portfolio; and providing other services. The Manager also used the management fees to fund commission payments and other compensation (collectively, “Distribution Related Payments”) paid to the dealers and brokers for securities of the Fund bought and held by investors.

The following dealers, who are affiliated with Counsel, may be entitled to Distribution Related Payments from Counsel on the same basis as unrelated registered brokers and dealers: IPC Securities Corporation, Investors Group Securities Inc., IPC Investment Corporation, Investors Group Financial Services Inc. and Quadrus Investment Services Ltd.

During the period, approximately 40% of the total management fee revenues received from all Counsel funds were used to fund Distribution Related Payments to registered dealers and brokers. In comparison, such Distribution Related Payments for the Fund represented 30% of the management fees paid. This amount is an average percentage of the management fees paid by all series. The actual percentage for each series may be higher or lower than the average depending on the level of trailing commissions and sales commissions paid for that series. The lower proportion of Distribution Related Payments is primarily attributable to the Fund having a higher proportion of investors in Series F and I compared to the average for all Counsel Funds; these series do not pay commissions.

Series Information

The Fund may issue an unlimited number of securities for each series. The number of issued and outstanding securities of each series is disclosed in *Financial Highlights*. A 10-year history of the major changes affecting the Fund can be found in the Fund’s Annual Information Form, available at www.counselservices.com.

¹ As described in the Fund’s Simplified Prospectus, securities of this series purchased under the sales charge purchase option may be subject to a fee of up to 5%; securities purchased under the redemption charge or low-load purchase options may be subject to a redemption fee of up to 6% or 3% respectively.

² A negotiable advisory or asset-based fee (plus sales taxes) is payable by investors to their dealer(s) in connection with the securities held in this series. The fee may be collected by Counsel from the investor’s account through redemption of securities and remitted to the dealer at the investor’s request. Alternatively, the dealer may collect it directly from the investor. Investors in this series may be eligible for a management fee reduction subject to meeting certain requirements as discussed in the Fund’s Simplified Prospectus.

³ Securities of this series are not subject to sales charges or redemption charges.

⁴ The management fee for this series is 1.05% and is payable directly to Counsel generally through the monthly redemption of securities.

⁵ There are no management or administration fees for this series since these securities are designed to facilitate fund-of-fund investing where duplication of management fees is prohibited.

⁶ There are no management fees for Series Private Wealth. An investor must enter into an agreement to participate in the IPC Private Wealth Program and agree to pay certain asset-based fees.

⁷ Counsel may, at its discretion, waive or lower the management fee (either directly or indirectly) and/or administration fee payable by investors.

⁸ Prior to October 27, 2017, this series was called Series D.

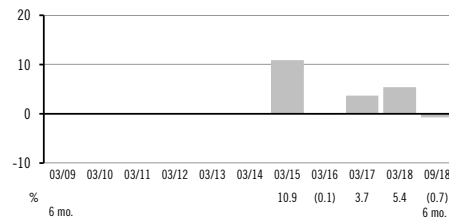

Year-by-Year Returns

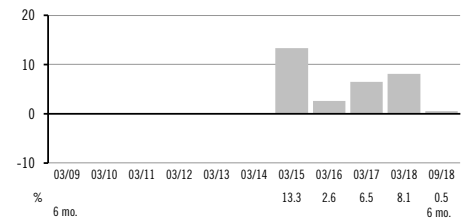
The bar chart shows how much an investment made on the first day of each financial year would have increased or decreased by the end of the respective periods. For the first year of a series, the percentage

shown will be the actual return of the series from its inception date, which can be found under *Series Information*. The chart illustrates how the Fund's performance has changed over time.

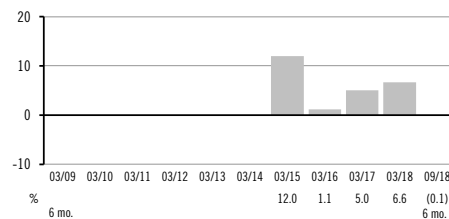

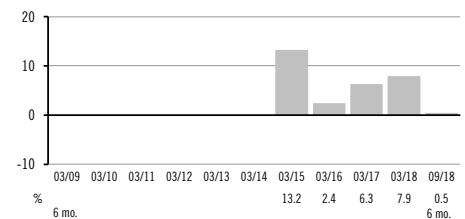
SERIES O



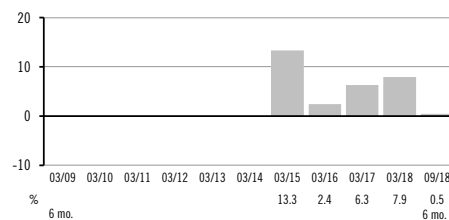
SERIES F

The higher PTR in a period, the greater the trading costs payable by the Fund in the period, and the greater the chance of an investor receiving taxable capital gains in the period. There is not necessarily a relationship between a high PTR and the performance of the Fund. Costs incurred to realign the Fund's portfolio after a fund merger, if any, are excluded from the PTR.
