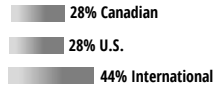

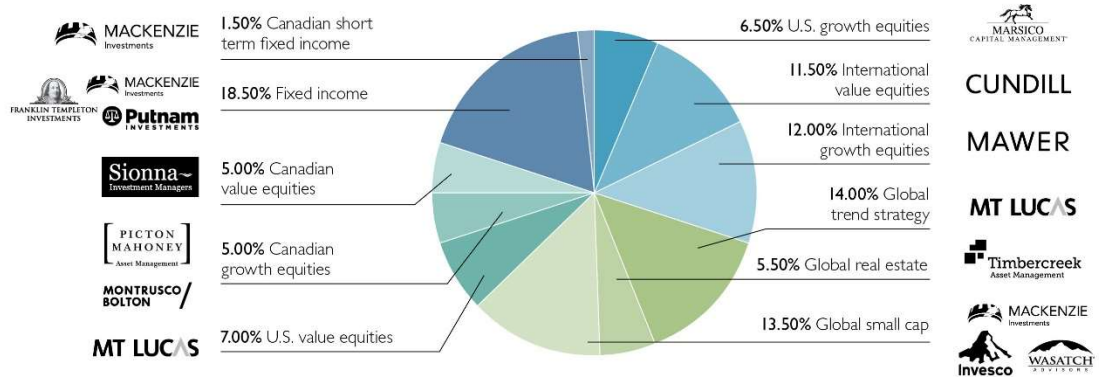

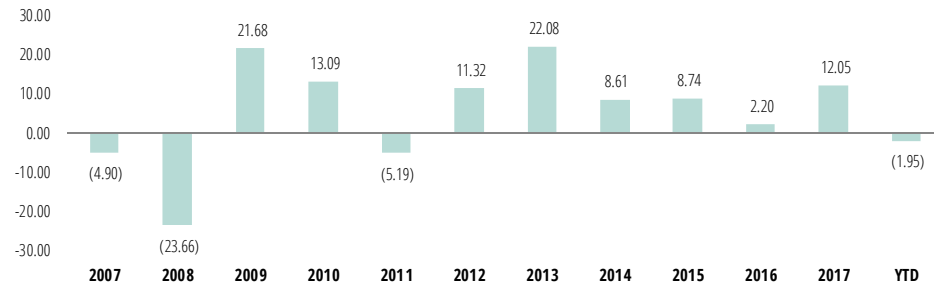
**Target Portfolio Allocation<sup>1</sup>**



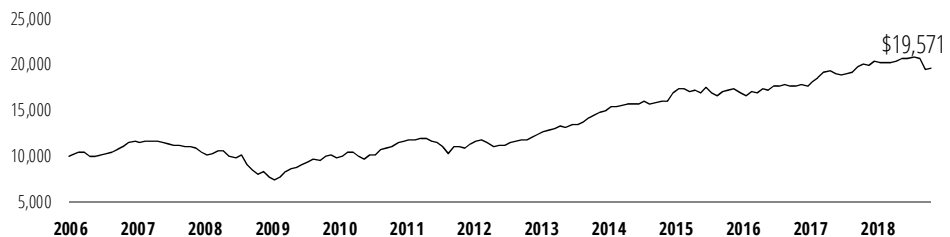

**Performance (%) Calendar Year Returns**



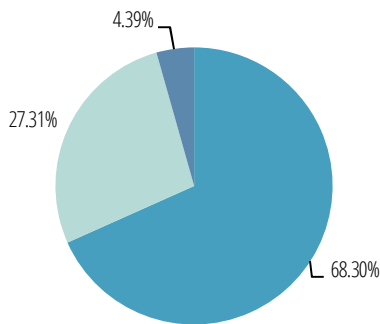
**Historical Performance (\$) Current Value of a \$10,000 Investment**



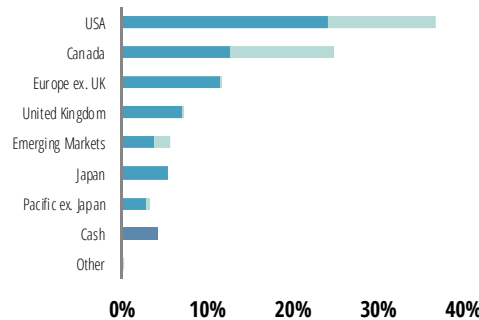

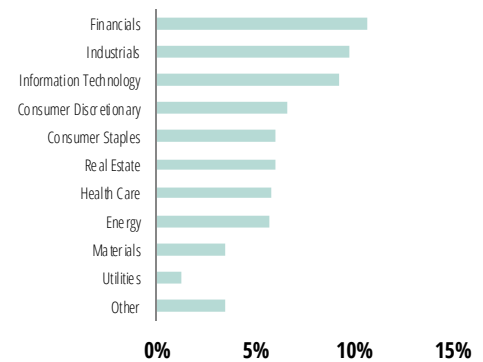
**Asset Class Mix**
