Management Discussion of Fund Performance

November 13, 2018

This Interim Management Report of Fund Performance is intended to present the significant factors and developments that have affected the Fund's performance and outlook since March 31, 2018, the Fund's last fiscal year-end. For information on the Fund's longer-term performance, please refer to the *Past Performance* section of the report. In this report, "Counsel" refers to Counsel Portfolio Services Inc., the manager of the Fund.

In addition, net asset value (NAV) refers to the value of the Fund or a series as calculated for transaction purposes, on which the discussion of Fund performance is based.

Results of Operations

Investment Performance

The performance of the Fund's Series A securities is discussed below. The performance of all other series offered by the Fund is shown in the *Past Performance* section of this report. Series returns may differ for a number of reasons, including if the series was not issued and outstanding for the entire reporting period and because of different levels of fees and expenses charged to each series. Please refer to the *Series Information* section of this report for the varying management and administration fees payable by series.

During the year, the Fund's Series A securities returned 2.37% (after deducting fees and expenses). This compares with the 6.86% return of a blended benchmark comprised of 75% MSCI World Net Total Return Index (returned 7.08%) and 25% S&P/TSX Composite Index (returned 6.16%) (the "Blended Benchmark"). All index and series returns are calculated on a total return basis in Canadian dollar terms. Investors cannot invest in an index without incurring fees, expenses and commissions, none of which are reflected in the index returns.

The Fund underperformed the broad-based MSCI World Total Return Index. The broad-based index is comprised of equities weighted by market capitalization to different regions, whereas the Fund has a substantially larger allocation to Canada. Given the Fund's composition, the Blended Benchmark provides a more meaningful comparison.

The Fund underperformed the Blended Benchmark due to its overweighting of international equities. The Fund's underlying international equity funds detracted from performance. Counsel International Value underperformed its benchmark primarily due to security selection within the Materials, Financials, and Consumer Staples sectors. Counsel International Growth underperformed its benchmark due to security selection within the Energy, Health Care, and Consumer Staples sectors.

Between April 1, 2018 and June 6, 2018, the Fund's effective target hedge against the U.S. Dollar ("USD") ranged from 25% to 50%. The hedge was removed on June 6, 2018. During the six-month period, the USD appreciated 0.32% against the Canadian Dollar ("CAD"). As a result, the currency hedge detracted from the Fund's performance.

The underlying equity funds were generally unhedged against international currencies, other than the USD. During the period, the CAD appreciated by 5.56% against a broad basket of international currencies, as weighted in the MSCI EAFE index. As a result, the Fund's foreign currency exposure had a negative impact on performance.

Net Assets

The Fund's NAV increased by \$3.4 million, or 4.9%, to \$72.5 million as at September 30, 2018, from \$69.1 million at March 31, 2018. Of this increase, \$2.0 million was attributable to investment performance (after deducting fees and expenses), \$0.8 million due to merger with Counsel All Equity Portfolio Class, and \$0.6 million due to net sales.

Fees and Expenses

The Management Expense Ratio ("MER") for Series A of 2.73%, during the period ended September 30, 2018, was slightly higher than the MER of 2.72% for the year ended March 31, 2018. The MERs (before and after waivers or absorptions, if any) are presented in the *Financial Highlights* section of this report.

Recent Developments

While global economic growth was synchronized earlier in the year, more recently there has been a de-coupling of the U.S. from the rest of the world. U.S. macro-economic data continues to be very strong, while trade disputes and rising U.S. interest rates have led to slowdowns in international markets, particularly Emerging Markets ("EMs").

In August, with U.S. equity markets at or near record levels, Counsel trimmed the Fund's exposure to U.S. and Canadian equities. The Fund is now underweight these markets in favour of international equities, which Counsel views as offering better risk-adjusted opportunities. Counsel also increased the Fund's investment in Counsel Global Trend Strategy to provide some protection against market stress. This fund systematically shifts assets from equities to lower-risk assets based on momentum signals and currently holds 50% of its assets in short-term government bonds.

Rising bond yields are an ongoing concern as bond prices decline when yields are rising. At the end of the third quarter, bond yields approached 3%, a level above which they may become attractive as an alternative to dividend stocks.

Subsequent to the end of the period, the Fund re-introduced its effective target hedge against the USD gradually increasing it to 95%. The USD hedge is dynamic and may vary between 0-100% at Counsel's discretion based on its assessment of currency market conditions. The Fund is expected to remain generally unhedged against currencies other than the USD for the foreseeable future.

Related Party Transactions

Management and Administration Services

For each applicable series, the Fund paid management fees and administration fees to Counsel at the annual rates specified under *Series Information* in this report and as more fully described in the Simplified Prospectus. In return for the administration fees, Counsel pays all costs and expenses (other than certain specified fund costs) required to operate the Fund. See also *Management Fees*.

Other Related Party Transactions

Series Private Wealth securities are issued on a prospectus-exempt basis to investors in the IPC Private Wealth program offered by IPC Securities Corporation, an affiliate of Counsel. At September 30, 2018, Series Private Wealth investors owned 0.1% of the Fund's NAV. As of September 30, 2018, Counsel had not received notice of any large redemptions. All related party transactions are based on the NAV per security on each transaction day.

The Fund relied on an approval from the Counsel Funds' Independent Review Committee ("IRC") with respect to its merger with Counsel All Equity Portfolio Class on September 7, 2018. Additionally, the Fund relied on standing instructions from the IRC with respect to asset re-allocations.

Management Fees

The Fund's management fees were used by the Manager to pay for: costs of managing the investment portfolio; providing investment analysis and recommendations; making investment decisions; the purchase and sale of the investment portfolio; and providing other services. The Manager also used the management fees to fund commission payments and other compensation (collectively, "Distribution Related Payments") paid to the dealers and brokers for securities of the Fund bought and held by investors.

The following dealers, who are affiliated with Counsel, may be entitled to Distribution Related Payments from Counsel on the same basis as unrelated registered brokers and dealers: IPC Securities Corporation, Investors Group Securities Inc., IPC Investment Corporation, Investors Group Financial Services Inc. and Quadrus Investment Services Ltd.

During the period, approximately 40% of the total management fee revenues received from all Counsel funds were used to fund Distribution Related Payments to registered dealers and brokers. In comparison, such Distribution Related Payments for the Fund represented 34% of the management fees paid. This amount is an average percentage of the management fees paid by all series. The actual percentage for each series may be higher or lower than the average depending on the level of trailing commissions and sales commissions paid for that series.

Series Information

The Fund may issue an unlimited number of securities for each series. The number of issued and outstanding securities of each series is disclosed in *Financial Highlights*. A 10-year history of the major changes affecting the Fund can be found in the Fund's Annual Information Form, available at www.counselinvestments.com.

¹ As described in the Fund's Simplified Prospectus, securities of this series purchased under the sales charge purchase option may be subject to a fee of up to 5%; securities purchased under the redemption charge or low-load purchase options may be subject to a redemption fee of up to 6% or 3% respectively. On September 4, 2018, the management fee was reduced from 2.12% to 2.10%.

² A negotiable advisory or asset-based fee (plus sales taxes) is payable by investors to their dealer(s) in connection with the securities held in this series. The fee may be collected by Counsel from the investor's account through redemption of securities and remitted to the dealer at the investor's request. Alternatively, the dealer may collect it directly from the investor. Investors in this series may be eligible for a management fee reduction subject to meeting certain requirements as discussed in the Fund's Simplified Prospectus.

³ On September 4, 2018, the management fee was reduced from 1.17% to 1.15%. Prior to October 27, 2017, this series was called Series D.

⁴ Securities of this series are not subject to sales charges or redemption charges.

⁵ The management fee for this series is 1.15% and is payable directly to Counsel generally through the monthly redemption of securities. On September 4, 2018, the management fee was reduced from 1.17% to 1.15%.

⁶ Counsel may, at its discretion, waive or lower the management fee (either directly or indirectly) and/or administration fee payable by investors.

⁷ There are no management fees for Series Private Wealth. An investor must enter into an agreement to participate in the IPC Private Wealth Program and agree to pay certain asset-based fees.

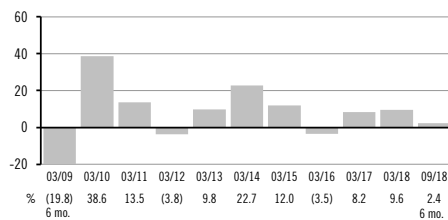
- In January 2010, the Fund began to pay an administration fee. In exchange, the Manager began to pay certain operating costs and expenses that had previously been paid by the Fund.

Year-by-Year Returns

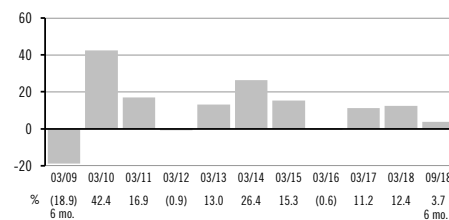
The bar chart shows how much an investment made on the first day of each financial year would have increased or decreased by the end of the respective periods. For the first year of a series, the percentage

shown will be the actual return of the series from its inception date, which can be found under *Series Information*. The chart illustrates how the Fund's performance has changed over time.

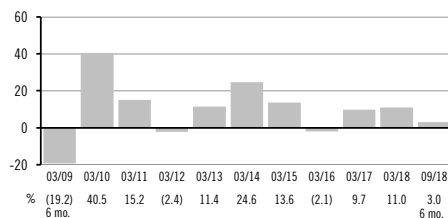

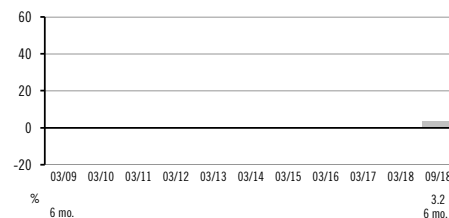

A PTR of 100% is equivalent to the Fund buying and selling all of the securities in its portfolio once in the course of the period. The higher PTR in a period, the greater the trading costs payable by the Fund in the period, and the greater the chance of an investor receiving taxable capital gains in the period. There is not necessarily a relationship between a high PTR and the performance of the Fund. Costs incurred to realign the Fund's portfolio after a fund merger, if any, are excluded from the PTR.
