Management Discussion of Fund Performance

November 13, 2018

This Interim Management Report of Fund Performance is intended to present the significant factors and developments that have affected the Fund's performance and outlook since March 31, 2018, the Fund's last fiscal year-end. For information on the Fund's longer-term performance, please refer to the *Past Performance* section of the report. In this report, "Counsel" refers to Counsel Portfolio Services Inc., the manager of the Fund.

In addition, net asset value (NAV) refers to the value of the Fund or a series as calculated for transaction purposes, on which the discussion of Fund performance is based.

Results of Operations

Investment Performance

The performance of the Fund's Series A securities is discussed below. The performance of all other series offered by the Fund is shown in the *Past Performance* section of this report. Series returns may differ for a number of reasons, including if the series was not issued and outstanding for the entire reporting period and because of different levels of fees and expenses charged to each series. Please refer to the *Series Information* section of this report for the varying management and administration fees payable by series.

During the six-month period, the Fund's Series A securities returned -3.00% (after deducting fees and expenses). This compares with a 0.36% return of the broad-based MSCI EAFE Index, and an -1.23% return of the style-based MSCI EAFE Value Index. All series returns are calculated on a total return basis in Canadian dollar terms. Investors cannot invest in an index without incurring fees, expenses and commissions, none of which are reflected in the index returns.

The broad-based index is designed to measure the performance of the overall international equity market, whereas the Fund invests with a focus on value-oriented equities. Given the Fund's composition, the style-based index provides a more meaningful comparison for relative performance.

The Fund underperformed the broad-based and style-based indices primarily due to security selection within the Materials, Financials and Consumer Staples sectors. Security selection within Telecommunications and Energy contributed to performance.

The Fund was generally unhedged against international currencies, other than the U.S. Dollar and the Brazilian Real. During the period, the Canadian dollar appreciated by 5.56% against a broad basket of international currencies, as weighted in the MSCI EAFE index. As a result, the Fund's foreign currency exposure had a negative impact on performance.

Net Assets

The Fund's NAV increased by \$7.8 million, or 2.3%, to \$349.8 million as at September 30, 2018, from \$342.0 million at March 31, 2018. Of this increase, \$13.6 million was attributable to net sales and partially offset by a \$5.8 million decrease due to investment performance (after deducting fees and expenses).

Certain other Counsel Funds ("Top Funds") and/or investment products managed by Counsel's affiliates have large investments in the Fund, see *Other Related Party Transactions* for details. As a result of these investments, the Fund is subject to large transaction risk as discussed in the Simplified Prospectus. Counsel manages this risk to reduce the possibility of any adverse effect on the value of the Fund or on its investors, through such processes as requiring advance notice of large redemptions.

Fees and Expenses

The Management Expense Ratio ("MER") for Series A of 2.58%, during the period ended September 30, 2018, was slightly higher than the MER of 2.57% for the year ended March 31, 2018. The MERs (before and after waivers or absorptions, if any) are presented in the *Financial Highlights* section of this report.

Recent Developments

In the U.S., GDP growth, capital expenditure, earnings improvement and consumer confidence have been leading the rest of the world, thanks to the corporate tax cut and accelerated depreciation of capital investments. The unemployment rate continues to drop and Mackenzie, the Fund's sub-advisor, believes wage pressures are building but does not see a significant risk of recession in the near term. The view is more positive as the current expansion could likely keep extending. Energy prices have improved combined with global crude inventory now well below the 5-year average led by reduced supply from Venezuela, sanctions against Iran, and lack of energy investments in recent years. If a recovery in offshore energy drilling and services occurs the Fund is well positioned to benefit from it.

There are some indications that the U.K. may be close to having a Brexit deal agreed with the EU. Mackenzie believes a deal to allow for a form of "soft Brexit" is likely but these negotiations could drag on. Meanwhile, the UK economy is holding up reasonably during these negotiations.

The ongoing trade war between China and the U.S. is putting pressure on the technology hardware sector in China and consumer confidence has started to weaken. In the long run, China has tremendous growth even if the pace of growth is slower than the past decade. In Japan, there are signs that the corporate sector has improved its focus on shareholder returns in the last couple of years due to reforms initiated by the Abe government.

As at September 30, 2018, the Fund had selected hedges against the U.S. Dollar and Brazilian Real. The Fund is expected to remain generally unhedged against other currencies for the foreseeable future.

Related Party Transactions

Management and Administration Services

For each applicable series, the Fund paid management fees and administration fees to Counsel at the annual rates specified under *Series Information* in this report and as more fully described in the Simplified Prospectus. In return for the administration fees, Counsel pays all costs and expenses (other than certain specified fund costs) required to operate the Fund. See also *Management Fees*.

Other Related Party Transactions

Other investment funds managed by Counsel (“Top Funds”) invest in Series O securities offered by the Fund on a prospectus-exempt basis in accordance with the investment objectives of those funds. Series Private Wealth securities are issued on a prospectus-exempt basis to investors in the IPC Private Wealth program offered by IPC Securities Corporation, an affiliate of Counsel. At September 30, 2018, Top Funds owned 77.2% of the Fund’s NAV and Series Private Wealth investors owned 18.8% of the Fund’s NAV. As of September 30, 2018, Counsel had not received notice of any large redemptions. All related party transactions are based on the NAV per security on each transaction day.

The Fund did not rely on an approval, positive recommendation, or standing instruction from the Counsel Funds’ Independent Review Committee (“IRC”) with respect to any related party transactions.

Management Fees

The Fund’s management fees were used by the Manager to pay for: costs of managing the investment portfolio; providing investment analysis and recommendations; making investment decisions; the purchase and sale of the investment portfolio; and providing other services. The Manager also used the management fees to fund commission payments and other compensation (collectively, “Distribution Related Payments”) paid to the dealers and brokers for securities of the Fund bought and held by investors.

The following dealers, who are affiliated with Counsel, may be entitled to Distribution Related Payments from Counsel on the same basis as unrelated registered brokers and dealers: IPC Securities Corporation, Investors Group Securities Inc., IPC Investment Corporation, Investors Group Financial Services Inc. and Quadrus Investment Services Ltd.

During the period, approximately 40% of the total management fee revenues received from all Counsel funds were used to fund Distribution Related Payments to registered dealers and brokers. In comparison, such Distribution Related Payments for the Fund represented 46% of the management fees paid. This amount is an average percentage of the management fees paid by all series. The actual percentage for each series may be higher or lower than the average depending on the level of trailing commissions and sales commissions paid for that series. As Series E of this Fund pays lower management fees than Series A of most other Counsel Funds while generally paying the same trailer fee, Distribution Related Payments comprise a higher proportion of the Fund’s management fee than the average for all Counsel Funds.

Series Information

The Fund may issue an unlimited number of securities for each series. The number of issued and outstanding securities of each series is disclosed in *Financial Highlights*. A 10-year history of the major changes affecting the Fund can be found in the Fund’s Annual Information Form, available at www.counselinvestments.com.

² A negotiable advisory or asset-based fee (plus sales taxes) is payable by investors to their dealer(s) in connection with the securities held in this series. The fee may be collected by Counsel from the investor’s account through redemption of securities and remitted to the dealer at the investor’s request. Alternatively, the dealer may collect it directly from the investor. Investors in this series may be eligible for a management fee reduction subject to meeting certain requirements as discussed in the Fund’s Simplified Prospectus.

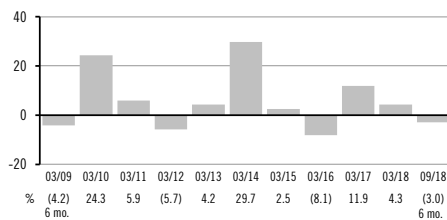
- In January 2010, the Fund began to pay an administration fee. In exchange, the Manager began to pay certain operating costs and expenses that had previously been paid by the Fund.

Year-by-Year Returns

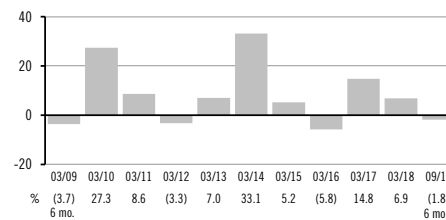
The bar chart shows how much an investment made on the first day of each financial year would have increased or decreased by the end of the respective periods. For the first year of a series, the percentage

shown will be the actual return of the series from its inception date, which can be found under *Series Information*. The chart illustrates how the Fund's performance has changed over time.

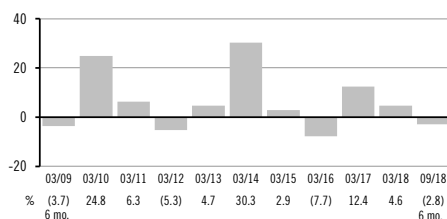

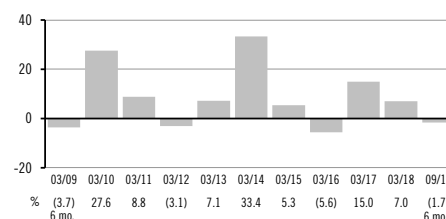

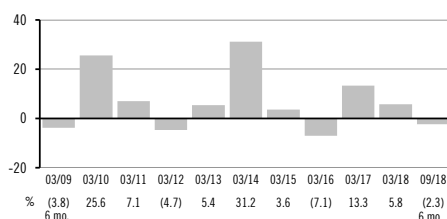

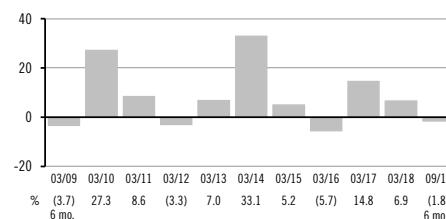
