The resulting Portfolio is concentrated, takes a systematic approach to holding periods, and is unconstrained by market capitalization or sector weighting. Depending on the prevailing market conditions, Counsel U.S. Value may also invest in U.S. fixed income securities and equity and fixed income securities of issuers anywhere in the world.

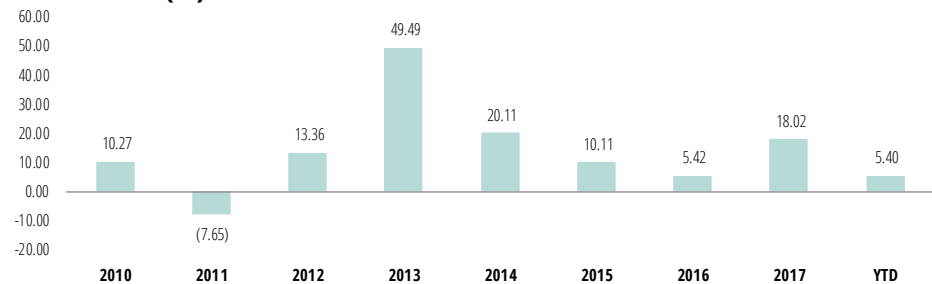

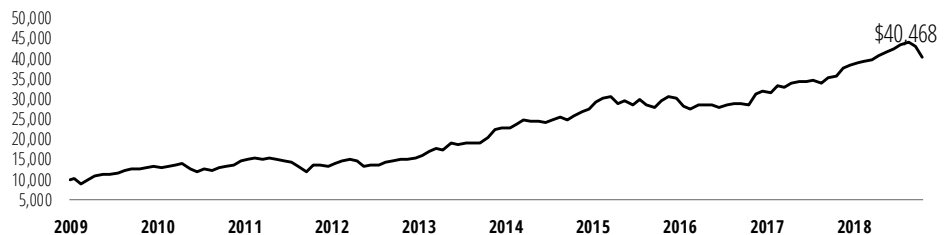

Performance (%) Calendar Year Returns

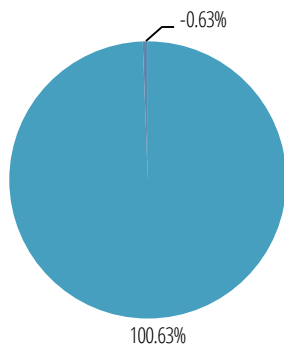


Historical Performance (\$) Current Value of a \$10,000 Investment

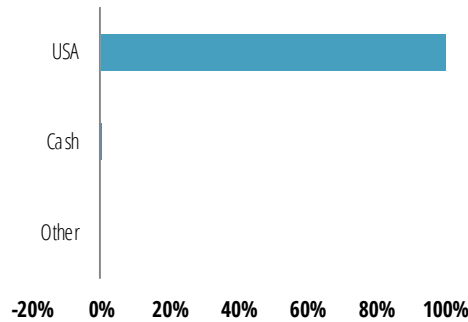

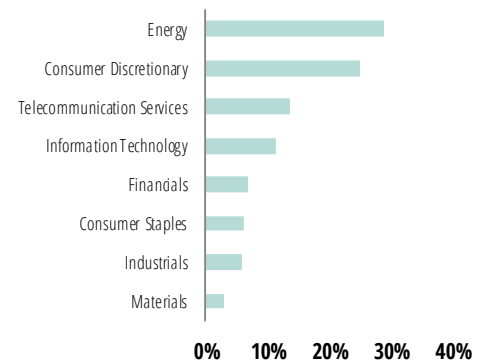
Asset Class Mix
