Management Discussion of Fund Performance

June 7, 2018

This Management Discussion of Fund Performance intends to present the significant factors and developments during the year ended March 31, 2018, that have affected the Fund's performance and outlook. For information on the Fund's longer-term performance, as applicable, please refer to the Past Performance section of the report. In this report, Counsel or the Manager refers to Counsel Portfolio Services Inc., the manager of the Fund.

In addition, net asset value (NAV) refers to the value of the Fund or a series as calculated for transaction purposes, on which the discussion of Fund performance is based.

Investment Objective and Strategies

The Fund seeks long-term capital growth with the potential for capital accumulation by aiming to reduce the impact of sustained periods of negative performance from investment markets. The Fund invests in global fixed-income securities and equity securities, either directly or through securities of other investment funds (the Underlying Funds).

Risk

The risks of investing in the Fund remain as discussed in the Fund's Simplified Prospectus. The Fund is suitable for retirees or pre-retirees who: aim to accumulate savings through a global balanced fund to hold as key part of their portfolio; want a medium to long-term investment; can handle the ups and downs of stock and bond markets; desire protection from sustained periods of negative investment market performance; and have a low to medium tolerance for risk.

Results of Operations

Investment Performance

The performance of the Fund's Series A securities is discussed below. The performance of all other series offered by the Fund is shown in the *Past Performance* section of this report. Series returns may differ for a number of reasons, including if the series was not issued and outstanding for the entire reporting period and because of different levels of fees and expenses charged to each series. Please refer to the *Series Information* section of this report for the varying management and administration fees payable by each series.

During the year, the Fund's Series A securities returned 6.24% (after deducting fees and expenses). This compares with an 8.11% return of a blended benchmark comprised of 80% MSCI World Index (returned 9.81%) and 20% FTSE TMX Canada Bond Universe Index (returned 1.36%) (the "Blended Benchmark"). All index and series returns are calculated on a total return basis in Canadian dollar

terms. Investors cannot invest in an index without incurring fees, expenses and commissions, none of which are reflected in the index returns.

The Fund underperformed the broad-based MSCI World Index. The broad-based index is comprised of global equities and has no exposure to fixed income securities, whereas the Fund invests in both equity and fixed-income securities. Given the Fund's composition, the Blended Benchmark provides a more meaningful comparison for relative performance.

The Fund underperformed the Blended Benchmark primarily due to the Fund's exposure to Counsel Global Low Volatility Equity, which underperformed the broader MSCI World Index. The underlying fund has a strategic underweight in Cyclical sectors and overweight Defensive sectors. Cyclical sectors such as Technology, Industrials, Financials and Consumer Discretionary outperformed this fund's overweight positions defensive sectors such as Health Care, Consumer Staples, and Utilities. The Fund is designed to incrementally reduce equity exposure during periods of market stress and target lower volatility experience. As a result, the underperformance during increasing global equity markets is expected.

In April 2017, the Fund's target effective hedge against the U.S. Dollar ("USD") was re-established. The hedge ranged from 50% to 65% between April 5, 2017 and January 5, 2018, at which time it was removed. It was subsequently re-established at 50% on February 7, 2018 and was reduced to 25% on March 5, 2018. During the year, the Canadian dollar ("CAD") appreciated 3.33% against the USD; as a result, the currency hedge contributed to the Fund's performance. Also, the Fund has been generally unhedged against international currencies other than the USD. During the year, the CAD depreciated by 5.67% against a broad basket of international currencies, as weighted in the MSCI EAFE index. As a result, the Fund's non-USD currency exposures have had a positive performance impact on the Fund.

Net Assets

The Fund's NAV increased by \$34.7 million, or 89.6%, to \$73.4 million as at March 31, 2018, from \$38.7 million at March 31, 2017. Of this increase, \$31.2 million was attributable to net sales and \$3.5 million due to investment performance (after deducting fees and expenses).

Certain other investment products managed by Counsel's affiliates have large investments in the Fund, see *Other Related Party Transactions* for details. As a result of these investments, the Fund is subject to large transaction risk as discussed in the Simplified Prospectus. Counsel manages this risk to reduce the possibility of any adverse effect on the value of the Fund or on its investors, through such processes as requiring advance notice of large redemptions.

Fees and Expenses

The Management Expense Ratio ("MER") for Series A of 2.53%, during the year ended March 31, 2018, was lower than the MER of 2.64% for the year ended March 31, 2017. The decrease was due to reductions in the MERs of underlying equity funds due to their reduced investments in exchange traded funds. The MERs (before and after waivers or absorptions, if any) are presented in the *Financial Highlights* section of this report.

Recent Developments

In the sub-advisor's opinion, an improving global economic and earnings backdrop supported equity markets in 2017 and is expected to remain in place through the coming year, despite recent concerns on trade issues. While the fundamental backdrop remains positive, there are a number of risks emerging to equity markets in recent months. Most recently, concerns related to a potential global trade war have proliferated as President Trump continues with threats of imposing tariffs on U.S. imports from China causing equity markets to retreat from their earlier all-time highs with negative repercussions for global growth. Given the well-known costs associated with a full-blown trade war, it is not expected that such an escalation will occur.

In the sub-advisor's opinion, signs of higher wage and headline inflation in the U.S. earlier this year gave rise to fears of significantly more aggressive tightening of monetary policy by the U.S. Federal Reserve with potentially higher bond yields which could pose difficulties for equities. While some pick-up in inflation is likely, it is expected to be modest and not result in significantly higher bond yields or a significant increase in the pace of interest rate increases by the Federal Reserve and other central banks. Other issues which could negatively impact equity markets through the year include political uncertainties and tensions across Europe, the U.S., the Middle East and Asia.

The Fund currently has an effective partial target hedge against the USD. The USD hedge is dynamic and may vary between 0-100% at Counsel's discretion based on its assessment of currency market conditions. The Fund is expected to remain generally unhedged against currencies other than the USD for the foreseeable future.

Related Party Transactions

Management and Administration Services

For each applicable series, the Fund paid management fees and administration fees to Counsel at the annual rates specified under *Series Information* in this report and as more fully described in the Simplified Prospectus. In return for the administration fees, Counsel pays all costs and expenses (other than certain specified fund costs) required to operate the Fund. See also *Management Fees*.

Other Related Party Transactions

Series Private Wealth securities are issued on a prospectus-exempt basis to investors in the IPC Private Wealth program offered by IPC Securities Corporation, an affiliate of Counsel. At March 31, 2018, Series Private Wealth investors owned 5.9% of the Fund's NAV. As of March 31, 2018, Counsel had not received notice of any large redemptions. All related party transactions are based on the NAV per security on each transaction day.

The Fund did not rely on an approval or positive recommendation from the Counsel Funds' Independent Review Committee (IRC) with respect to any related party transactions. The Fund has relied on standing instructions from the IRC with respect to asset re-allocations.

Management Fees

The Fund's management fees were used by the Manager to pay for: costs of managing the investment portfolio; providing investment analysis and recommendations; making investment decisions; the purchase and sale of the investment portfolio; and providing other services. The Manager also used the management fees to fund commission payments and other compensation (collectively, "Distribution Related Payments") paid to the dealers and brokers for securities of the Fund bought and held by investors.

The following dealers, who are affiliated with Counsel, may be entitled to Distribution Related Payments from Counsel on the same basis as unrelated registered brokers and dealers: IPC Securities Corporation, Investors Group Securities Inc., IPC Investment Corporation, Investors Group Financial Services Inc., and Quadrus Investment Services Ltd.

During the year, approximately 42% of the total management fee revenues received from all Counsel funds were used to fund Distribution Related Payments to registered dealers and brokers. In comparison, such Distribution Related Payments for the Fund represented 46% of the management fees paid. This amount is an average percentage of the management fees paid by all series. The actual percentage for each series may be higher or lower than the average depending on the level of trailing commissions and sales commissions paid for that series. The higher proportion of Distribution Related Payments is primarily attributable to commissions related to sales of redemption charge securities of the Fund.

Series Information

The Fund may issue an unlimited number of securities for each series. The number of issued and outstanding securities of each series is disclosed in *Financial Highlights*. A 10-year history of the major changes affecting the Fund can be found in the Fund's Annual Information Form, available at www.counsel-services.com.

¹ As described in the Fund's Simplified Prospectus, securities of this series purchased under the sales charge purchase option may be subject to a fee of up to 5%; securities purchased under the redemption charge or low-load purchase options may be subject to a redemption fee of up to 6% or 3% respectively.

² A negotiable advisory or asset-based fee (plus sales taxes) is payable by investors to their dealer(s) in connection with the securities held in this series. The fee may be collected by Counsel from the investor's account through redemption of securities and remitted to the dealer at the investor's request. Alternatively, the dealer may collect it directly from the investor. Investors in this series may be eligible for a management fee reduction subject to meeting certain requirements as discussed in the Fund's Simplified Prospectus.

³ The management fee for this series is 0.95% and is payable directly to Counsel generally through the monthly redemption of securities.

⁴ Effective October 28, 2016, the Series F administration fee was reduced from 0.25% to 0.15%. Additionally, the minimum investment for Series I was reduced from \$150,000 to \$1,000.

⁵ Securities of this series are not subject to sales charges or redemption charges.

⁶ There are no management fees for Series Private Wealth. An investor must enter into an agreement to participate in the IPC Private Wealth Program and agree to pay certain asset-based fees. Prior to November 21, 2016, this series was called Series P.

⁷ Counsel may, at its discretion, waive or lower the management fee (either directly or indirectly) and/or administration fee payable by investors.

⁸ This series is available solely to those investing through a private client service offering from IPC Investment Corporation and IPC Securities Corporation.

⁹ Prior to October 27, 2017, this series was called Series D.

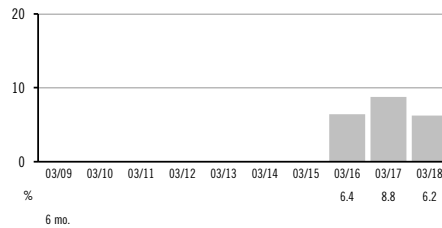

Year-by-Year Returns

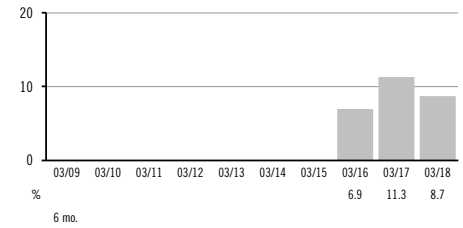
The bar chart shows how much an investment made on the first day of each financial year would have increased or decreased by the end of the respective periods. For the first year of a series, the percentage

shown will be the actual return of the series from its inception date, which can be found under *Series Information*. The chart illustrates how the Fund's performance has changed over time.

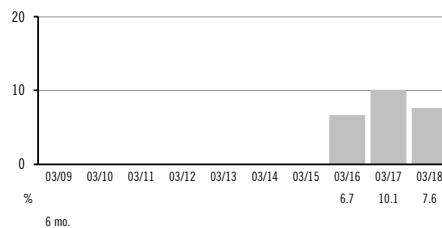

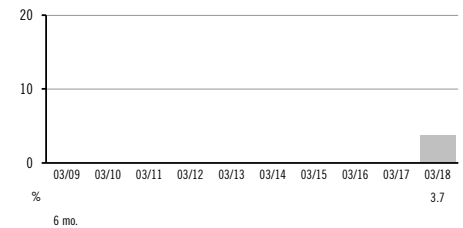
SERIES PRIVATE WEALTH



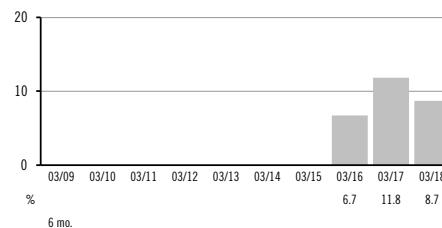
