Management Discussion of Fund Performance

November 14, 2017

This Interim Management Report of Fund Performance is intended to present the significant factors and developments that have affected the Fund's performance and outlook since March 31, 2017, the Fund's last fiscal year-end. For information on the Fund's longer-term performance, please refer to the *Past Performance* section of the report. In this report, "Counsel" refers to Counsel Portfolio Services Inc., the manager of the Fund.

In addition, net asset value ("NAV") refers to the value of the Fund or a series as calculated for transaction purposes, on which the discussion of Fund performance is based.

Results of Operations

Investment Performance

The performance of the Fund's Series A securities is discussed below. The performance of all other series offered by the Fund is shown in the *Past Performance* section of this report. Series returns may differ for a number of reasons, including if the series was not issued and outstanding for the entire reporting period and because of different levels of fees and expenses charged to each series. Please refer to the *Series Information* section of this report for the varying management and administration fees payable by series.

During the 6-month period, the Fund's Series A securities returned 3.14% (after deducting fees and expenses). This compares with the 1.64% return of a blended index comprised of 20% FTSE TMX Canada Bond Universe Total Return Index (returned -0.75%), 60% MSCI World Total Return Index (returned 2.27%) and 20% S&P/TSX Composite Index (returned 1.99%) (the "Blended Index"). All index and series returns are calculated on a total return basis in Canadian dollar terms. Investors cannot invest in an index without incurring fees, expenses and commissions, none of which are reflected in the index returns.

The Fund outperformed the broad-based MSCI World Total Return Index, which returned 2.27%. The broad-based index is comprised of equities and has no exposure to fixed income securities, whereas the Fund invests in equity and fixed-income mutual funds. Given the Fund's composition, the Blended Index provides a more meaningful comparison.

The Fund outperformed the Blended Index due to the underweight positioning of Canadian equities and overweighting U.S. and international equities. Exposure to Counsel Global Small Cap as well as Counsel Global Trend Strategy contributed to the Fund's performance.

The Fund's exposure to Growth mandates also contributed to performance. Counsel International Growth outperformed its benchmark primarily due to security selection in the Industrials and Financials sectors. Counsel U.S. Growth outperformed primarily due to its overweight to and security selection within the Consumer Staples and Information Technology sectors. No exposure to Energy or Telecommunication Services also contributed to performance. Counsel Canadian Growth benefited from security selection in Energy, Industrials, Materials and Telecommunication Services sector. Being overweight in Consumer Discretionary and Industrials also contributed positively to performance.

The Fund's performance was negatively impacted by the performance of its underlying Fixed Income components and an overweighting to the Real Estate sector compared to the broader MSCI World. The Fund's investment in Counsel Fixed Income detracted primarily due to its exposure to high yield fixed income and global fixed income securities, which underperformed investment grade fixed income securities over the period.

In April 2017, the underlying equity funds' target hedge against the U.S. Dollar ("USD") was re-established ranging from 50% to 65% during the period. During the 6-month period, the Canadian dollar ("CAD") appreciated 7.24% against the USD; as a result, the currency hedge contributed to the Fund's performance. Over the period, the underlying equity funds have been generally unhedged against international currencies other than the USD. During the period, the CAD appreciated by 1.27% against a broad basket of international currencies, as weighted in the MSCI EAFE index. As a result, the Fund's non-USD currency exposures have had a negative performance impact on the Fund.

Net Assets

The Fund's NAV increased by \$10.9 million, or 2.8%, to \$398.9 million as at September 30, 2017, from \$388.0 million at March 31, 2017. Of this increase, \$13.3 million was attributable to investment performance (after deducting fees and expenses) and slightly offset by a \$2.4 million decrease due to net redemptions.

Certain other Counsel Funds ("Top Funds") and/or investment products managed by Counsel's affiliates have large investments in the Fund, see *Other Related Party Transactions* for details. As a result of these investments, the Fund is subject to large transaction risk as discussed in the Simplified Prospectus. Counsel manages this risk to reduce the possibility of any adverse effect on the value of the Fund or on its investors, through such processes as requiring advance notice of large redemptions.

Fees and Expenses

The Management Expense Ratio ("MER") for Series A of 2.68%, during the period ended September 30, 2017, was lower than the MER of 2.84% for the year ended March 31, 2017. The MER decreased due to a reduction of management fees effective October 28, 2016, as noted in the Series Information section of the report. The MERs (before and after waivers or absorptions, if any) are presented in the *Financial Highlights* section of this report.

Recent Developments

During the period, the Bank of Canada raised its key policy interest rate twice, both in 25 basis point increments, with the rate now at 1.0%. Expectations within the market are for a third rate hike by mid-2018 at the latest. Rate increases are also well underway in the U.S., where the Federal Reserve is implementing a plan to reduce money supply by selling treasury bonds back into the market. In contrast, the European Central Bank continues to hold its interest rate at 0% but has opened the door to winding down its stimulus program.

Counsel reduced the Fund's exposure to high yield bonds during the period. While the outlook for high yield is mildly positive, we are slightly more cautious on the fundamentals given the rising interest rate environment in North America. Volatility in the financial markets has been exceptionally low, and high yield markets are overvalued in the manager's view.

Counsel continues to view non-North American equity markets, especially emerging markets, as offering better risk-adjusted opportunities. Growth in emerging markets is stabilizing faster than developed markets while inflation is falling. This viewpoint is reflected in the Fund's allocations continuing to be tilted toward global securities.

Despite heightened optimism, in global markets, we are mindful of both equity and fixed-income valuations, especially for U.S. equities. We believe equity valuations are still slightly elevated and are being driven by low interest rates and bond yields. The same can be said of fixed income valuations, which have been artificially compressed by low interest rates used by the central banks to stimulate the economy. Since the low in March 2009, investors have enjoyed above average returns. Although we do not predict a significant downturn, we believe future returns will be relatively muted.

The underlying equity funds currently have a partial USD target hedge. The USD hedge is dynamic and may vary between 0-100% at Counsel's discretion based on its assessment of currency market conditions. It is expected that, in the near term, the underlying equity funds will maintain the current hedge. The Fund is expected to remain generally unhedged against currencies other than the USD for the foreseeable future.

Related Party Transactions

Management and Administration Services

For each applicable series, the Fund paid management fees and administration fees to Counsel at the annual rates specified under *Series Information* in this report and as more fully described in the Simplified Prospectus. In return for the administration fees, Counsel pays all costs and expenses (other than certain specified fund costs) required to operate the Fund. See also *Management Fees*.

Other Related Party Transactions

Series Private Wealth securities are issued on a prospectus-exempt basis to investors in the IPC Private Wealth program offered by IPC Securities Corporation, an affiliate of Counsel. At March 31, 2017, Series Private Wealth investors owned 2.8% of the Fund's NAV. As of March 31, 2017, Counsel had not received notice of any large redemptions. All related party transactions are based on the NAV per security on each transaction day.

The Fund did not rely on an approval, positive recommendation, or standing instruction from the Counsel Funds' Independent Review Committee with respect to any related party transactions.

Management Fees

The Fund's management fees were used by the Manager to pay for: costs of managing the investment portfolio; providing investment analysis and recommendations; making investment decisions; the purchase and sale of the investment portfolio; and providing other services. The Manager also used the management fees to fund commission payments and other compensation (collectively, "Distribution Related Payments") paid to the dealers and brokers for securities of the Fund bought and held by investors.

The following dealers, who are affiliated with Counsel, may be entitled to Distribution Related Payments from Counsel on the same basis as unrelated registered brokers and dealers: IPC Securities Corporation, Investors Group Securities Inc., IPC Investment Corporation, Investors Group Financial Services Inc. and Quadrus Investment Services Ltd.

During the period, approximately 41% of the total management fee revenues received from all Counsel funds were used to fund Distribution Related Payments to registered dealers and brokers. In comparison, such Distribution Related Payments for the Fund represented 41% of the management fees paid. This amount is an average percentage of the management fees paid by all series. The actual percentage for each series may be higher or lower than the average depending on the level of trailing commissions and sales commissions paid for that series.

Series Information

The Fund may issue an unlimited number of securities for each series. The number of issued and outstanding securities of each series is disclosed in *Financial Highlights*. A 10-year history of the major changes affecting the Fund can be found in the Fund's Annual Information Form, available at www.counselinvestments.com.

¹ As described in the Fund's Simplified Prospectus, securities of this series purchased under the sales charge purchase option may be subject to a fee of up to 5%; securities purchased under the redemption charge or low-load purchase options may be subject to a redemption fee of up to 6% or 3% respectively.

² A negotiable advisory or asset-based fee (plus sales taxes) is payable by investors to their dealer(s) in connection with the securities held in this series. The fee may be collected by Counsel from the investor's account through redemption of securities and remitted to the dealer at the investor's request. Alternatively, the dealer may collect it directly from the investor. Investors in this series may be eligible for a management fee reduction subject to meeting certain requirements as discussed in the Fund's Simplified Prospectus.

³ Effective October 28, 2016, the Series A management fee was reduced from 2.36% to 2.06% and the Series D administration fee was reduced from 0.31% to 0.15%. Additionally, the minimum investment for Series I was reduced from \$150,000 to \$1,000.

⁴ Securities of this series are not subject to sales charges or redemption charges.

⁵ On November 4, 2016, Series E securities were redesignated as Series A securities, resulting in a consolidation of the series' assets.

⁶ The management fee for this series is 1.07% and is payable directly to Counsel generally through the monthly redemption of securities.

⁷ There are no management fees for Series Private Wealth. An investor must enter into an agreement to participate in the IPC Private Wealth Program and agree to pay certain asset-based fees. Prior to November 21, 2016, this series was called Series P.

⁸ Counsel may, at its discretion, waive or lower the management fee (either directly or indirectly) and/or administration fee payable by investors.

⁹ This series is available solely to those investing through a private client service offering from IPC Investment Corporation and IPC Securities Corporation.

¹⁰ As of October 27, 2017, Series D securities were renamed Series F securities.

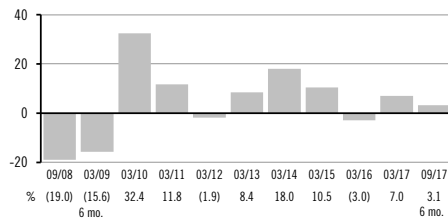
- During some performance measurement periods certain fees or expenses may have been waived or absorbed by the Manager. There is no assurance that fees will be waived in the future.

Year-by-Year Returns

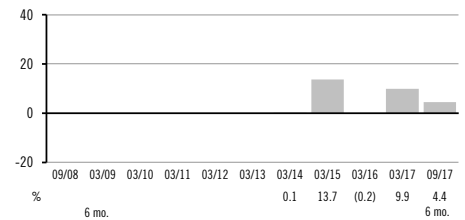

the percentage shown will be the actual return of the series from its inception date, which can be found under *Series Information*. The chart illustrates how the Fund's performance has changed over time.

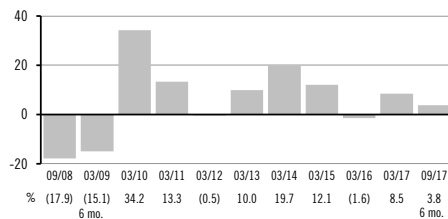

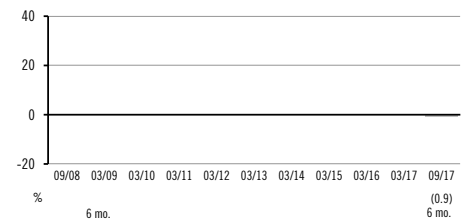
SERIES PRIVATE WEALTH



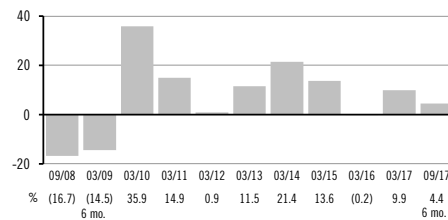
