Management Discussion of Fund Performance

November 12, 2019

This Management Discussion of Fund Performance presents the views of Counsel Portfolio Services Inc. (“Counsel”) on the significant factors and developments during the period ended September 30, 2019, that have affected the Fund’s performance and outlook. For information on the Fund’s longer-term performance please refer to the *Past Performance* section of the report.

In addition, net asset value (NAV) refers to the value of the Fund or a series as calculated for transaction purposes, on which the discussion of Fund performance is based.

Results of Operations

Investment Performance

The performance of the Fund’s Series A securities is discussed below. The performance of all other series offered by the Fund is shown in the *Past Performance* section of this report. Series returns may differ for a number of reasons, including if the series was not issued and outstanding for the entire reporting period and because of different levels of fees and expenses charged to each series. Please refer to the *Series Information* section of this report for the varying management and administration fees payable by series.

During the six-month period, the Fund’s Series A securities returned 0.66% (after deducting fees and expenses). This compares with a 3.99% return of a blended benchmark comprised of 45% MSCI World Total Return Index (returned 3.62%), 40% FTSE TMX Canada Bond Universe Total Return Index (returned 3.73%), and 15% S&P/TSX Composite Index (returned 5.13%) (the “Blended Benchmark”). All index and series returns are calculated on a total return basis in Canadian dollar terms. Investors cannot invest in an index without incurring fees, expenses and commissions, none of which are reflected in the index returns.

The Fund underperformed the broad-based MSCI World Total Return Index. The broad-based index is comprised of equities and has no exposure to fixed income securities, whereas the Fund invests in equity and fixed-income mutual funds. Given the Fund’s composition, the Blended Benchmark provides a more meaningful comparison.

The Fund underperformed the Blended Benchmark due to its overweighting of international equities, which underperformed compared to North American equities. The Fund’s allocation to Counsel Global Trend Strategy detracted because of its defensive positioning at certain times when markets were rising. Counsel U.S. Value also underperformed its benchmark due to sub-sector allocation decisions within the Financials sector, as well as security selection within the Consumer Discretionary sector.

The global fixed income mandate within the underlying Counsel Fixed Income underperformed primarily due to its underweighted exposure to U.S. Treasuries. Among currency positions in Latin America, the Argentine peso detracted from performance.

During the period, the Canadian dollar (“CAD”) appreciated 0.94% against the U.S. Dollar (“USD”). As a result, the Fund’s USD currency exposures negatively impacted fund performance; the Fund’s partial hedge in effect at the beginning and the end of the period modestly offset some of this impact.

The Fund is predominantly unhedged against international currencies other than the USD. During the period, the CAD appreciated by 2.96% against a broad basket of international currencies, as weighted in the MSCI EAFE index. As a result, the Fund’s non-USD currency exposures negatively impacted the Fund’s performance.

Net Assets

The Fund’s NAV declined by \$76.6 million, or 4.0%, to \$1.86 billion as at September 30, 2019, from \$1.93 billion at March 31, 2019. Of this decrease, \$98.9 million was attributable to net redemptions and partially offset by a \$22.3 million increase due to investment performance (after deducting fees and expenses).

Fees and Expenses

The Management Expense Ratio (“MER”) for Series A of 2.44%, during the period ended September 30, 2019, was unchanged from the year ended March 31, 2019. The MERs for all series (before and after waivers or absorptions, if any) are presented in the *Financial Highlights* section of this report.

Recent Developments

Global equity markets generated low-to-mid single-digit returns during the six-month period, cooling after a strong start to the year. Supportive interest rate policies from global central banks counterbalanced a deteriorating economic and earnings backdrop. With absolute valuations close to historical all-time highs, Counsel believes there is limited upside in equity markets over the remainder of the year, particularly as economic risks and uncertainties remain. With further downward revisions to both economic and earnings forecasts possible, we believe the risks to equity markets are currently skewed to the downside; an effectively diversified portfolio helps to mitigate this risk.

If there is continued upside to equity markets, the Fund is adequately positioned to participate. We also believe the Fund should be able to limit the potential impact of a correction by equity markets should that occur. We continue to maintain the Fund’s investment in Counsel Global Trend Strategy to provide an element of downside protection against market stress. Over the mid-to-long term, we expect that global markets will perform better than domestic markets. Valuations in

the U.S. are higher than normal, which makes U.S. stocks very expensive. As a result, the Fund remains biased towards international equities.

In May, the sub-advisor for the underlying Counsel International Value was changed from Mackenzie Investments to Thompson, Siegel & Walmsley LLC. In July, Picton Mahoney Asset Management, assumed 100% sub-advisory duties of the underlying Counsel Canadian Growth following the departure of Montrusco Bolton which was managing 20% of that fund.

In November 2019, 12% of the Fund was allocated to the recently launched IPC Multi-Factor equity funds. The move is intended to improve diversification and minimize volatility. These three underlying funds intend to replicate indices constructed by index provider Scientific Beta which invests using a quantitative factor-based approach to select specific securities. The Fund’s exposures to existing underlying Canadian, U.S. and international equity funds were concurrently lowered.

The Fund has an equal target weighting to both Growth and Value equities in its make-up, meaning that half of the equity allocations have trailed as Growth has outperformed for much of the last decade. In September, Value stocks started to outperform Growth stocks. A return to favour by Value stocks would provide a lift to the Fund with its equal weighting between investment styles. Concurrent with the re-allocation to the IPC Multi-Factor funds, Value stocks have been given an increased relative weighting compared to Growth stocks.

The underlying equity funds’ target effective hedge of 50% against USD exposure was eliminated in mid-October 2019. The USD hedge is dynamic and may vary between 0-100% at our discretion based on our assessment of currency market conditions. The Fund is expected to remain predominantly unhedged against currencies other than the USD subject to our discretion based on our assessment of currency market conditions.

Related Party Transactions

Management and Administration Services

For each applicable series, the Fund paid management fees and administration fees to Counsel at the annual rates specified under *Series Information* in this report and as more fully described in the Simplified Prospectus. In return for the administration fees, Counsel pays all costs and expenses (other than certain specified fund costs) required to operate the Fund. See also *Management Fees*.

Other Related Party Transactions

Series Private Wealth securities are issued on a prospectus-exempt basis to investors in the IPC Private Wealth program offered by IPC Securities Corporation, an affiliate of Counsel. At September 30, 2019, Series Private Wealth investors owned 5.1% of the Fund's NAV. As of September 30, 2019, Counsel had not received notice of any large redemptions. All related party transactions are based on the NAV per security on each transaction day.

Management Fees

The Fund's management fees were used by the Manager to pay for: costs of managing the investment portfolio; providing investment analysis and recommendations; making investment decisions; the purchase and sale of the investment portfolio; and providing other services. The Manager also used the management fees to fund commission payments and other compensation (collectively, "Distribution Related Payments") paid to the dealers and brokers for securities of the Fund bought and held by investors.

The following dealers, who are affiliated with Counsel, may be entitled to Distribution Related Payments from Counsel on the same basis as unrelated registered brokers and dealers: IPC Securities Corporation, Investors Group Securities Inc., IPC Investment Corporation, Investors Group Financial Services Inc. and Quadrus Investment Services Ltd.

During the period, approximately 35% of the total management fee revenues received from all Counsel funds were used to fund Distribution Related Payments to registered dealers and brokers. In comparison, such Distribution Related Payments for the Fund represented 32% of the management fees paid. This amount is an average percentage of the management fees paid by all series. The actual percentage for each series may be higher or lower than the average depending on the level of trailing commissions and sales commissions paid for that series.

Series Information

The Fund may issue an unlimited number of securities for each series. The number of issued and outstanding securities of each series is disclosed in *Financial Highlights*. A 10-year history of the major changes affecting the Fund can be found in the Fund's Annual Information Form, available at www.counselinvestments.com.

¹ As described in the Fund's Simplified Prospectus, securities of this series purchased under the sales charge purchase option may be subject to a fee of up to 5%; securities purchased under the redemption charge or low-load purchase options may be subject to a redemption fee of up to 6% or 3% respectively.

² A negotiable advisory or asset-based fee (plus sales taxes) is payable by investors to their dealer(s) in connection with the securities held in this series. The fee may be collected by Counsel from the investor's account through redemption of securities and remitted to the dealer at the investor's request. Alternatively, the dealer may collect it directly from the investor. Investors in this series may be eligible for a management fee reduction subject to meeting certain requirements as discussed in the Fund's Simplified Prospectus.

⁸ This series is designed for investors who want to receive a monthly cash distribution at an annualized rate of up to 8% per year.

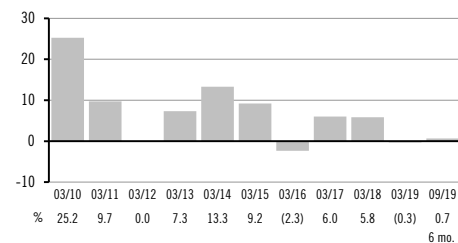
- In January 2010, the Fund began to pay an administration fee. In exchange, the Manager began to pay certain operating costs and expenses that had previously been paid by the Fund.

Year-by-Year Returns

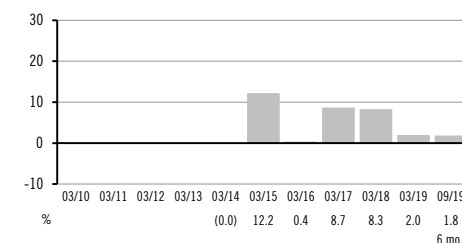
The bar chart shows how much an investment made on the first day of each financial year would have increased or decreased by the end of the respective periods. For the first year of a series, the percentage

shown will be the actual return of the series from its inception date, which can be found under *Series Information*. The chart illustrates how the Fund's performance has changed over time.

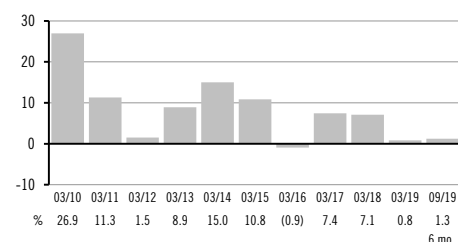

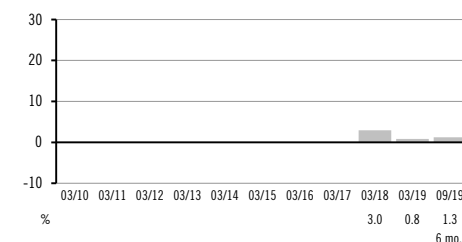
SERIES PRIVATE WEALTH



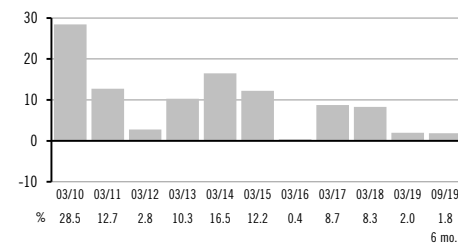

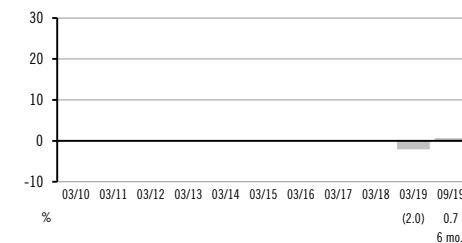
