Management Discussion of Fund Performance

November 12, 2019

This Management Discussion of Fund Performance presents the views of Counsel Portfolio Services Inc. ("Counsel") on the significant factors and developments during the period ended September 30, 2019, that have affected the Fund's performance and outlook. For information on the Fund's longer-term performance please refer to the *Past Performance* section of the report.

In addition, net asset value (NAV) refers to the value of the Fund or a series as calculated for transaction purposes, on which the discussion of Fund performance is based.

Results of Operations

Investment Performance

The performance of the Fund's Series A securities is discussed below. The performance of all other series offered by the Fund is shown in the *Past Performance* section of this report. Series returns may differ for a number of reasons, including if the series was not issued and outstanding for the entire reporting period and because of different levels of fees and expenses charged to each series. Please refer to the *Series Information* section of this report for the varying management and administration fees payable by series.

During the six-month period, the Fund's Series A securities returned 0.35% (after deducting fees and expenses). This compares with a 5.13% return of the broad-based S&P 500 Total Return Index and a 4.31% return of the style-based Russell 1000 Value Index. All index and series returns are calculated on a total return basis in Canadian dollar terms. Investors cannot invest in an index without incurring fees, expenses and commissions, none of which are reflected in the index returns.

The broad-based index is designed to measure the performance of the overall U.S. equity market, whereas the Fund invests with a focus on value-oriented equities. Given the Fund's composition, the style-based index provides a more meaningful comparison for relative performance.

The Fund underperformed the broad-based and style-based indices primarily due to sub-sector allocations within the Financials sector, as well as security selection within the Consumer Discretionary sector.

During the period, the Canadian dollar ("CAD") appreciated 0.94% against the U.S. Dollar ("USD"). As a result, the Fund's USD currency exposures negatively impacted fund performance; the Fund's partial hedge in effect at the beginning and the end of the period modestly offset some of this impact.

Net Assets

The Fund's NAV declined by \$12.8 million, or 7.0%, to \$171.2 million as at September 30, 2019, from \$184.0 million at March 31, 2019. Of this decrease, \$15.2 million was attributable to net redemptions and slightly offset by a \$2.4 million increase due to investment performance (after deducting fees and expenses).

Fees and Expenses

The Management Expense Ratio ("MER") for Series A of 2.42%, during the period ended September 30, 2019, was unchanged from the year ended March 31, 2019. The MERs for all series (before and after waivers or absorptions, if any) are presented in the *Financial Highlights* section of this report.

Recent Developments

There are two large uncertainties overhanging global markets, and the sub-advisor believes, at the least, interim resolutions to both, either good or bad, may come to pass in the next quarter. A broad agreement between the U.S. and China on trade, coupled with the unwinding of tariffs will likely lead to relief for world markets with activity in the U.S., China, and emerging markets will likely turn upwards. With Brexit, a negotiated deal is better than a no-deal exit by the U.K. from the European Union. In the sub-advisor's view, reasonable path forwards to a new broadly open trading relationship will be coupled with large scale fiscal response, as well as the monetary easing that has already happened. In this scenario, the ensuing growth would lead to higher bond yields, and concentrated deep value factors will outperform along with size and low volatility factors. Valuations for all three of these factors are relatively cheap compared to the median valuation of the past four years. Investors saw a small snippet of this outcome as Value outperformed Growth through September. However, if China and the U.S. can't come to terms, nor the U.K and the E.U., the sub-advisor believes markets will be negatively impacted, quality and momentum factors will continue to perform relatively well despite valuations being at the top end of the range over the past four years.

In September, the sub-advisor executed the second of the two portfolio rollovers, buying 20 stocks based on a combination of 80% Value characteristics and 20% Momentum characteristics. The largest sector allocation is now in Financials at 25.8%, an increase of 15.6% from the previous quarter end. Information Technology is the second largest sector allocation at 17.7%, a decrease of 2.8% versus the prior quarter. Consumer Discretionary is the third largest sector allocation at 12.6% and Real Estate is the fourth largest sector allocation at 11.3%. The strategy is invested in nine of the 11 GICS sectors. Life insurers are the largest allocation by industry, followed by real estate investment trusts, computer hardware & storage, airlines, and consumer finance.

The Fund's target hedge of 50% against USD exposure was eliminated in mid-October 2019. The USD hedge is dynamic and may vary between 0-100% at our discretion based on our assessment of currency market conditions.

Related Party Transactions

Management and Administration Services

For each applicable series, the Fund paid management fees and administration fees to Counsel at the annual rates specified under *Series Information* in this report and as more fully described in the Simplified Prospectus. In return for the administration fees, Counsel pays all costs and expenses (other than certain specified fund costs) required to operate the Fund. See also *Management Fees*.

Other Related Party Transactions

Other investment funds managed by Counsel ("Top Funds") invest in Series O securities offered by the Fund on a prospectus-exempt basis in accordance with the investment objectives of those funds. Series Private Wealth securities are issued on a prospectus-exempt basis to investors in the IPC Private Wealth program offered by IPC Securities Corporation, an affiliate of Counsel. At September 30, 2019, Top Funds owned 82.0% of the Fund's NAV and Series Private Wealth investors owned 4.6% of the Fund's NAV. As of September 30, 2019, Counsel had not received notice of any large redemptions. All related party transactions are based on the NAV per security on each transaction day.

The Fund did not rely on an approval, positive recommendation, or standing instruction from the Counsel Funds' Independent Review Committee ("IRC") with respect to any related party transactions.

Management Fees

The Fund's management fees were used by the Manager to pay for: costs of managing the investment portfolio; providing investment analysis and recommendations; making investment decisions; the purchase and sale of the investment portfolio; and providing other services. The Manager also used the management fees to fund commission payments and other compensation (collectively, "Distribution Related Payments") paid to the dealers and brokers for securities of the Fund bought and held by investors.

The following dealers, who are affiliated with Counsel, may be entitled to Distribution Related Payments from Counsel on the same basis as unrelated registered brokers and dealers: IPC Securities Corporation, Investors Group Securities Inc., IPC Investment Corporation, Investors Group Financial Services Inc. and Quadrus Investment Services Ltd.

During the period, approximately 35% of the total management fee revenues received from all Counsel funds were used to fund Distribution Related Payments to registered dealers and brokers. In comparison, such Distribution Related Payments for the Fund represented 42% of the management fees paid. This amount is an average percentage of the management fees paid by all series. The actual percentage for each series may be higher or lower than the average depending on the level of trailing commissions and sales commissions paid for that series. As Series E of this Fund pays lower management fees than Series A of most other Counsel Funds while generally paying the same trailer fee, Distribution Related Payments comprise a higher proportion of the Fund's management fee than the average for all Counsel Funds.

Series Information

The Fund may issue an unlimited number of securities for each series. The number of issued and outstanding securities of each series is disclosed in *Financial Highlights*. ² A negotiable advisory or asset-based fee (plus sales taxes) is payable by investors to their dealer(s) in connection with the securities held in this series. The fee may be collected by Counsel from the investor's account through redemption of securities and remitted to the dealer at the investor's request. Alternatively, the dealer may collect it directly from the investor. Investors in this series may be eligible for a management fee reduction subject to meeting certain requirements as discussed in the Fund's Simplified Prospectus.

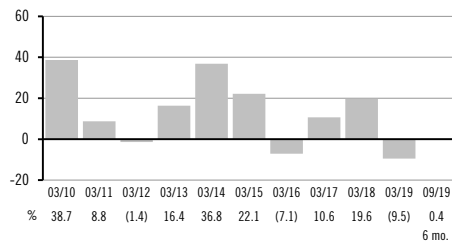

Year-by-Year Returns

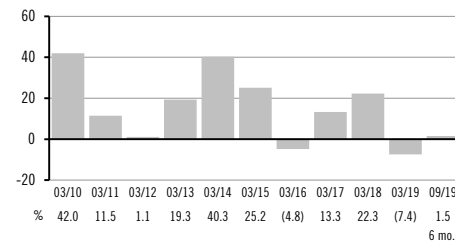
The bar chart shows how much an investment made on the first day of each financial year would have increased or decreased by the end of the respective periods. For the first year of a series, the percentage

shown will be the actual return of the series from its inception date, which can be found under *Series Information*. The chart illustrates how the Fund's performance has changed over time.

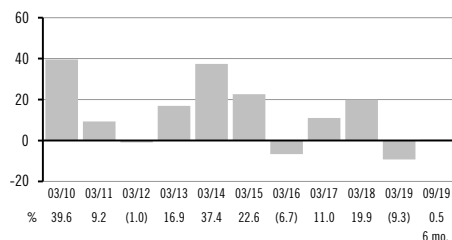

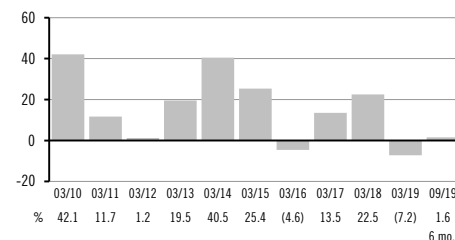

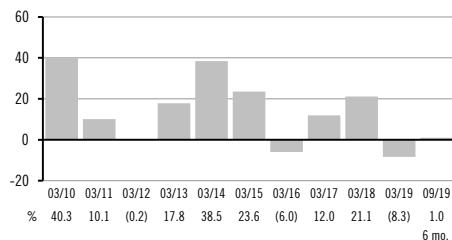

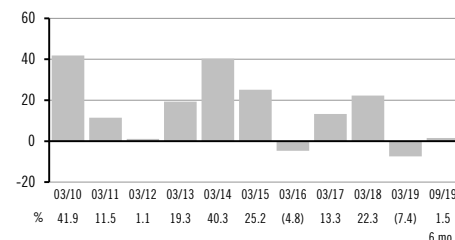
