Management Discussion of Fund Performance

November 12, 2019

This Management Discussion of Fund Performance presents the views of Counsel Portfolio Services Inc. (“Counsel”) on the significant factors and developments during the period ended September 30, 2019, that have affected the Fund’s performance and outlook. For information on the Fund’s longer-term performance please refer to the *Past Performance* section of the report.

In addition, net asset value (NAV) refers to the value of the Fund or a series as calculated for transaction purposes, on which the discussion of Fund performance is based.

Results of Operations

Investment Performance

The performance of the Fund’s Series A securities is discussed below. The performance of all other series offered by the Fund is shown in the *Past Performance* section of this report. Series returns may differ for a number of reasons, including if the series was not issued and outstanding for the entire reporting period and because of different levels of fees and expenses charged to each series. Please refer to the *Series Information* section of this report for the varying management and administration fees payable by series.

During the six-month period, the Fund’s Series A securities returned -2.04% (after deducting fees and expenses). This compares with a 3.62% return for the broad based MSCI World Total Return Index and a 3.12% return for the mandate-specific MSCI ACWI High Dividend Yield Total Return Index. All index and series returns are calculated on a total return basis in Canadian dollar terms. Investors cannot invest in an index without incurring fees, expenses and commissions, none of which are reflected in the index returns.

The Fund underperformed the broad-based MSCI World Total Return Index which is designed to measure the performance of developed equity markets, whereas the Fund invests with a focus on dividend-yielding equities. Given the Fund’s composition, the mandate-specific index provides a more meaningful comparison for relative performance.

The Fund underperformed the MSCI ACWI High Dividend Yield Total Return Index primarily due to its Value style orientation and stock selection within the Financials and Consumer Discretionary sectors.

During the period, the Canadian dollar (“CAD”) appreciated 0.94% against the U.S. Dollar (“USD”). As a result, the Fund’s USD currency exposures negatively impacted fund performance; the Fund’s partial hedge in effect at the beginning and the end of the period modestly offset some of this impact.

The Fund is unhedged against international currencies other than the USD. During the period, the CAD appreciated by 2.96% against a broad basket of international currencies, as weighted in the MSCI EAFE index. As a result, the Fund’s non-USD currency exposures negatively impacted the Fund’s performance.

Net Assets

The Fund’s NAV declined by \$2.8 million, or 2.5%, to \$109.7 million as at September 30, 2019, from \$112.5 million at March 31, 2019. Of this decrease, \$1.7 million was attributable to net redemptions and \$1.1 million due to investment performance (after deducting fees and expenses).

Fees and Expenses

The Management Expense Ratio (“MER”) for Series A of 2.67%, during the period ended September 30, 2019, was slightly lower than the MER of 2.68% for the year ended March 31, 2019. The MERs for all series (before and after waivers or absorptions, if any) are presented in the *Financial Highlights* section of this report.

Recent Developments

Value-oriented equities began to outperform growth-oriented stocks in early September 2019 which is a significant change compared to relative performance in recent history. The sub-advisor doesn’t want to speculate as to whether this is a style rotation indicating a cycle where Value stocks will relatively outperform but there is a general expectation this will occur at some point. This is especially likely if there is a recession as Value stocks tend to lead coming out of economic downturns.

Global markets begin the final quarter of 2019 facing heightened economic and geopolitical uncertainty in many key regions. Slowing growth is a major concern, acknowledged by efforts of both the U.S. Federal Reserve and European Central Bank to inject stimulus with rate cuts and bond purchase programs. The trade war remains the primary challenge to global economic growth, and specifically its impact on manufacturing and the knock-on effects felt in consumer spending. Europe’s manufacturing sector is in contraction, and the effects have been dramatic in emerging economies which often don’t have the robust services component to help buffer weak manufacturing. Overall, softening growth forecasts are not surprising given the lack of progress in resolving global trade friction, simmering geopolitical risk in Europe and Hong Kong, and political uncertainty in the U.S. The sub-advisor’s view is that risks are tilted to the downside and will remain so until world leaders are able to resolve trade differences and subdue political turmoil in key areas.

There have seen significant shifts in the sub-advisor’s country-level forecasts over the past quarter. Japan has displaced the U.K. as the top forecast. The outlook for Japan has improved, supported by strong growth as well as modest improvements in quality and risk measures. At the industry level, forecasts for semiconductors are favourably powered by strong value and positive momentum.

The Fund’s target hedge of 50% against USD exposure was eliminated in mid-October 2019. The USD hedge is dynamic and may vary between 0-100% at our discretion based on our assessment of currency market conditions. The Fund is expected to remain unhedged against currencies other than the USD subject to our discretion based on our assessment of currency market conditions.

Related Party Transactions

Management and Administration Services

For each applicable series, the Fund paid management fees and administration fees to Counsel at the annual rates specified under *Series Information* in this report and as more fully described in the Simplified Prospectus. In return for the administration fees, Counsel pays all costs and expenses (other than certain specified fund costs) required to operate the Fund. See also *Management Fees*.

Other Related Party Transactions

Other investment funds managed by Counsel (“Top Funds”) invest in Series O securities offered by the Fund on a prospectus-exempt basis in accordance with the investment objectives of those funds. Series Private Wealth securities are issued on a prospectus-exempt basis to investors in the IPC Private Wealth program offered by IPC Securities Corporation, an affiliate of Counsel. At September 30, 2019, Top Funds owned 42.1% of the Fund’s NAV and Series Private Wealth investors owned 21.5% of the Fund’s NAV. As of September 30, 2019, Counsel had not received notice of any large redemptions. All related party transactions are based on the NAV per security on each transaction day.

The Fund did not rely on an approval, positive recommendation, or standing instruction from the Counsel Funds’ Independent Review Committee (“IRC”) with respect to any related party transactions.

Management Fees

The Fund's management fees were used by the Manager to pay for: costs of managing the investment portfolio; providing investment analysis and recommendations; making investment decisions; the purchase and sale of the investment portfolio; and providing other services. The Manager also used the management fees to fund commission payments and other compensation (collectively, "Distribution Related Payments") paid to the dealers and brokers for securities of the Fund bought and held by investors.

The following dealers, who are affiliated with Counsel, may be entitled to Distribution Related Payments from Counsel on the same basis as unrelated registered brokers and dealers: IPC Securities Corporation, Investors Group Securities Inc., IPC Investment Corporation, Investors Group Financial Services Inc. and Quadrus Investment Services Ltd.

During the period, approximately 35% of the total management fee revenues received from all Counsel funds were used to fund Distribution Related Payments to registered dealers and brokers. In comparison, such Distribution Related Payments for the Fund represented 31% of the management fees paid. This amount is an average percentage of the management fees paid by all series. The actual percentage for each series may be higher or lower than the average depending on the level of trailing commissions and sales commissions paid for that series. The lower proportion of Distribution Related Payments is primarily attributable to the Fund's higher management fee rate compared to other Counsel Funds.

Series Information

The Fund may issue an unlimited number of securities for each series. The number of issued and outstanding securities of each series is disclosed in *Financial Highlights*. A 10-year history of the major changes affecting the Fund can be found in the Fund's Annual Information Form, available at www.counselinvestments.com.

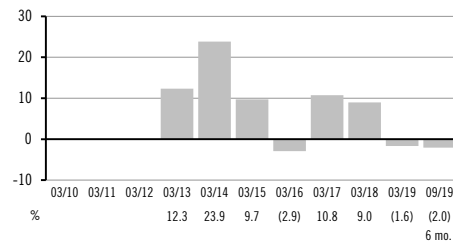

Year-by-Year Returns

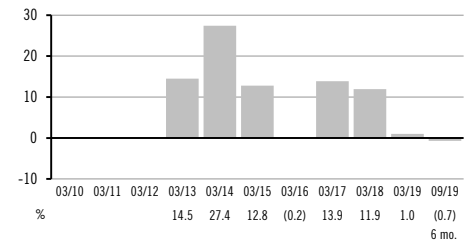
The bar chart shows how much an investment made on the first day of each financial year would have increased or decreased by the end of the respective periods. For the first year of a series, the percentage

shown will be the actual return of the series from its inception date, which can be found under *Series Information*. The chart illustrates how the Fund's performance has changed over time.

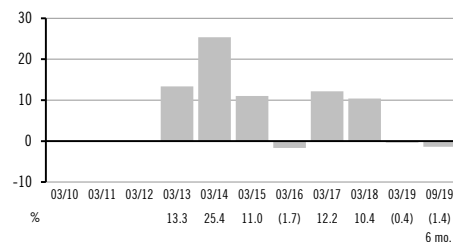

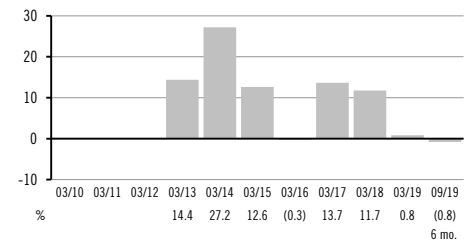

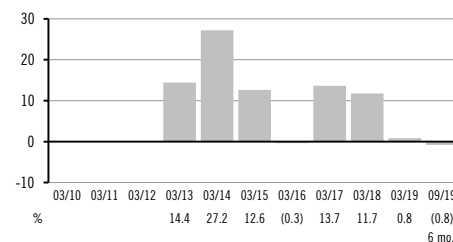
