Management Discussion of Fund Performance

November 12, 2019

This Management Discussion of Fund Performance presents the views of Counsel Portfolio Services Inc. (“Counsel”) on the significant factors and developments during the period ended September 30, 2019, that have affected the Fund’s performance and outlook. For information on the Fund’s longer-term performance please refer to the *Past Performance* section of the report.

In addition, net asset value (NAV) refers to the value of the Fund or a series as calculated for transaction purposes, on which the discussion of Fund performance is based.

Results of Operations

Investment Performance

The performance of the Fund’s Series A securities is discussed below. The performance of all other series offered by the Fund is shown in the *Past Performance* section of this report. Series returns may differ for a number of reasons, including if the series was not issued and outstanding for the entire reporting period and because of different levels of fees and expenses charged to each series. Please refer to the *Series Information* section of this report for the varying management and administration fees payable by series.

During the six-month period, the Fund’s Series A securities returned 3.75% (after deducting fees and expenses). This compares with a 5.13% return of the broad-based S&P/TSX Composite Total Return Index and a 5.63% return of the mandate-specific S&P/TSX Composite Dividend Total Return Index. All index and series returns are calculated on a total return basis in Canadian dollar terms. Investors cannot invest in an index without incurring fees, expenses and commissions, none of which are reflected in the index returns.

The broad-based index is designed to measure the performance of the entire Canadian equity market, whereas the Fund invests with a focus on dividend yielding equities. Given the Fund’s composition, the mandate-specific index provides a more meaningful comparison for relative performance.

The Fund underperformed both the broad-based and mandate-specific indices primarily due to its Value-style orientation as well as security selection within and an overweight to the Communication Services sector. Having no exposure to Consumer Discretionary and Information Technology sectors also detracted from performance.

Net Assets

The Fund’s NAV declined by \$2.3 million, or 3.6%, to \$63.2 million as at September 30, 2019, from \$65.5 million at March 31, 2019. Of this decrease, \$4.9 million was attributable to net redemptions and partially offset by a \$2.6 million increase due to investment performance (after deducting fees and expenses).

Fees and Expenses

The Management Expense Ratio (“MER”) for Series A of 2.33%, during the period ended September 30, 2019, was slightly lower than the MER of 2.35% for the year ended March 31, 2019. The MERs for all series (before and after waivers or absorptions, if any) are presented in the *Financial Highlights* section of this report.

Recent Developments

The Fund is overweight Communication Services, Energy (slightly higher exposure to pipelines), Financials (higher exposure to Insurance but lower exposure to the banks), Real Estate, and Utilities. The Fund is underweight Materials as certain portions of this sector do not pay adequate dividends and are not appropriately valued for inclusion in the Fund. The Fund has no exposure to Consumer Discretionary, Industrials, and Information Technology as many of these stocks in these sectors do not meet the Fund’s sub-advisor’s multiple criteria of valuation, quality, stability, and adequate dividends for this mandate. The sub-advisor remains cautious about equity markets, especially given the macroeconomic risks and the elevated valuations in certain sectors.

Towards the end of the period, markets experienced a “factor rotation,” causing outperformance of value stocks relative to their growth counterparts. The on-going trade war between the U.S. and China, as well as global economic growth uncertainty, led to a shift towards cheaply priced and defensive stocks. Within Canada, this shift was evident in the performance of the Utilities and Consumer Staples sectors, which tend to perform well during economic downturns. A return to favour by the Value sector would benefit the Fund as it is structured to take advantage of mispricing opportunities in higher quality names, while benefitting from the steady flow of above-average dividends from these holdings.

Related Party Transactions

Management and Administration Services

For each applicable series, the Fund paid management fees and administration fees to Counsel at the annual rates specified under *Series Information* in this report and as more fully described in the Simplified Prospectus. In return for the administration fees, Counsel pays all costs and expenses (other than certain specified fund costs) required to operate the Fund. See also *Management Fees*.

Other Related Party Transactions

Counsel is a subsidiary of IGM Financial Inc. (“IGM”). IGM is a subsidiary of Power Financial Corporation, which in turn is a subsidiary of Power Corporation of Canada. Companies related to Power Corporation of Canada are therefore considered affiliates of Counsel. As of September 30, 2019, the Fund held an investment in Power Financial Corporation valued at \$3.4 million. This investment is in accordance with standing instructions approved by the Counsel Funds’ Independent Review Committee (“IRC”) and represents 5.4% of the Fund’s net assets. The IRC issued the approval on the basis that these investments would be made in compliance with Counsel’s policies. Counsel’s policies are designed to ensure that the related party transaction:

- (i) is made free from any influence by an entity related to Counsel and without taking into account any considerations relevant to an entity related to Counsel;
- (ii) represents the business judgment of the sub-advisor, uninfluenced by considerations other than the best interests of the Fund; and
- (iii) achieves a fair and reasonable result for the Fund.

Other investment funds managed by Counsel (“Top Funds”) invest in Series O securities offered by the Fund on a prospectus-exempt basis in accordance with the investment objectives of those funds. As at September 30, 2019, Top Funds owned 13.7% of the Fund’s NAV and Series Private Wealth investors owned 4.4% of the Fund’s NAV. As of September 30, 2019, Counsel had not received notice of any large redemptions. All related party transactions are based on the NAV per security on each transaction day.

Management Fees

The Fund's management fees were used by the Manager to pay for: costs of managing the investment portfolio; providing investment analysis and recommendations; making investment decisions; the purchase and sale of the investment portfolio; and providing other services. The Manager also used the management fees to fund commission payments and other compensation (collectively, "Distribution Related Payments") paid to the dealers and brokers for securities of the Fund bought and held by investors.

The following dealers, who are affiliated with Counsel, may be entitled to Distribution Related Payments from Counsel on the same basis as unrelated registered brokers and dealers: IPC Securities Corporation, Investors Group Securities Inc., IPC Investment Corporation, Investors Group Financial Services Inc. and Quadrus Investment Services Ltd.

During the period, approximately 35% of the total management fee revenues received from all Counsel funds were used to fund Distribution Related Payments to registered dealers and brokers. In comparison, such Distribution Related Payments for the Fund represented 44% of the management fees paid. This amount is an average percentage of the management fees paid by all series. The actual percentage for each series may be higher or lower than the average depending on the level of trailing commissions and sales commissions paid for that series. As Series E of this Fund pays lower management fees than Series A of most other Counsel Funds while generally paying the same trailer fee, Distribution Related Payments comprise a higher proportion of the Fund's management fee than the average for all Counsel Funds.

Series Information

The Fund may issue an unlimited number of securities for each series. The number of issued and outstanding securities of each series is disclosed in *Financial Highlights*. ¹ As described in the Fund's Simplified Prospectus, securities of this series purchased under the sales charge purchase option may be subject to a fee of up to 5%; securities purchased under the redemption charge or low-load purchase options may be subject to a redemption fee of up to 6% or 3% respectively.

² A negotiable advisory or asset-based fee (plus sales taxes) is payable by investors to their dealer(s) in connection with the securities held in this series. The fee may be collected by Counsel from the investor's account through redemption of securities and remitted to the dealer at the investor's request. Alternatively, the dealer may collect it directly from the investor. Investors in this series may be eligible for a management fee reduction subject to meeting certain requirements as discussed in the Fund's Simplified Prospectus.

³ On September 4, 2018, the Series F management fee was reduced from 0.99% to 0.85% and the Series A management fee was reduced from 1.90% to 1.85%.

⁴ Securities of this series are not subject to sales charges or redemption charges.

⁵ The management fee for this series is 0.85% and is payable directly to Counsel generally through the monthly redemption of securities. On September 4, 2018, the management fee was reduced from 0.99% to 0.85%.

⁶ There are no management or administration fees for this series since these securities are designed to facilitate fund-of-fund investing where duplication of management fees is prohibited.

⁷ Counsel may, at its discretion, waive or lower the management fee (either directly or indirectly) and/or administration fee payable by investors.

⁸ This series is not available for purchase.

⁹ This series is designed for investors who want to receive a monthly cash distribution at an annualized rate of up to 8% per year.

¹⁰ There are no management fees for Series Private Wealth. An investor must enter into an agreement to participate in the IPC Private Wealth Program and agree to pay certain asset-based fees.

Past Performance

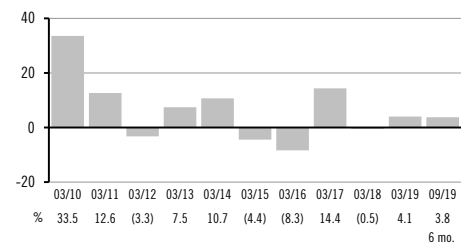
- In January 2010, the Fund began to pay an administration fee. In exchange, the Manager began to pay certain operating costs and expenses that had previously been paid by the Fund.

Year-by-Year Returns

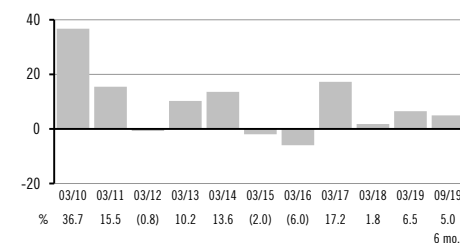
The bar chart shows how much an investment made on the first day of each financial year would have increased or decreased by the end of the respective periods. For the first year of a series, the percentage

shown will be the actual return of the series from its inception date, which can be found under *Series Information*. The chart illustrates how the Fund's performance has changed over time.

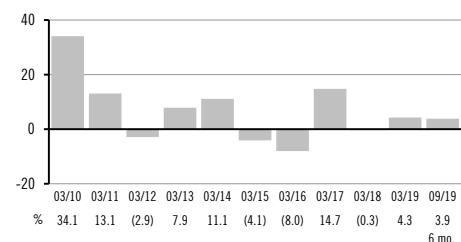

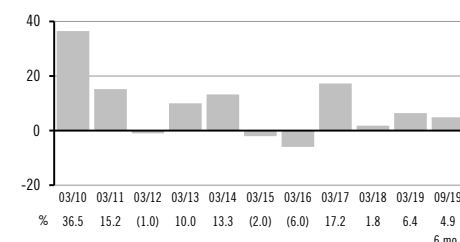

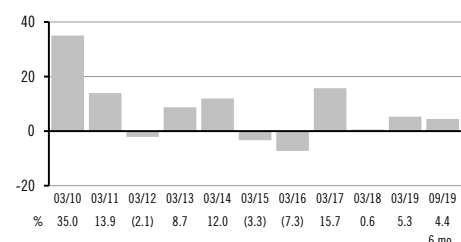

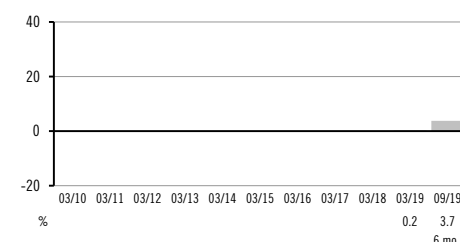

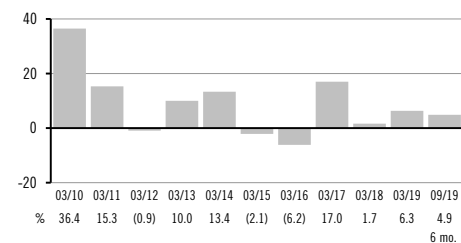
