# Management Discussion of Fund Performance

November 12, 2019

This Management Discussion of Fund Performance presents the views of Counsel Portfolio Services Inc. (“Counsel”) on the significant factors and developments during the period ended September 30, 2019, that have affected the Fund’s performance and outlook. For information on the Fund’s longer-term performance please refer to the *Past Performance* section of the report.

In addition, net asset value (NAV) refers to the value of the Fund or a series as calculated for transaction purposes, on which the discussion of Fund performance is based.

## Results of Operations

### Investment Performance

The performance of the Fund’s Series A securities is discussed below. The performance of all other series offered by the Fund is shown in the *Past Performance* section of this report. Series returns may differ for a number of reasons, including if the series was not issued and outstanding for the entire reporting period and because of different levels of fees and expenses charged to each series. Please refer to the *Series Information* section of this report for the varying management and administration fees payable by series.

During the six-month period, the Fund’s Series A securities returned 6.64% (after deducting fees and expenses). This compares with a 5.13% return of the broad-based S&P/TSX Composite Total Return Index and a 4.56% return of the style-based MSCI Canada Growth Index. All index and series returns are calculated on a total return basis in Canadian dollar terms. Investors cannot invest in an index without incurring fees, expenses and commissions, none of which are reflected in the index returns.

The broad-based index is designed to measure the performance of the overall Canadian equity market, whereas the Fund invests with a focus on growth oriented equities. Given the Fund’s composition, the style-based index provides a more meaningful comparison for relative performance.

The Fund outperformed both the broad-based index and the style-based index primarily due to security selection in Financials and Industrials sectors. The allocation to the Horizons S&P/TSX 60 Index ETF also outperformed the style-based index.

In early June, the 20% portion of the Fund sub-advised by Montrusco Bolton Investments was invested in Horizons ETF. In early July, Picton Mahoney Asset Management assumed 100% sub-advisory duties of the Fund following the departure of Montrusco Bolton. Throughout July, the Horizons ETF was sold and Picton Mahoney’s security selections were scaled up.

### Net Assets

The Fund’s NAV declined by \$8.6 million, or 6.0%, to \$135.1 million as at September 30, 2019, from \$143.7 million at March 31, 2019. Of this decrease, \$19.5 million was attributable to net redemptions and partially offset by a \$10.9 million increase due to investment performance (after deducting fees and expenses).

### Fees and Expenses

The Management Expense Ratio (“MER”) for Series A of 2.39%, during the period ended September 30, 2019, was unchanged from the year ended March 31, 2019. The MERs for all series (before and after waivers or absorptions, if any) are presented in the *Financial Highlights* section of this report.

## Recent Developments

As a global growth slowdown is increasingly discounted by bond markets, policymakers are confronting market expectations for immediate and sizable monetary stimulus. Macroeconomic risks such as trade tensions, Brexit, and meaningful elections on the horizon exacerbate the late cycle dynamics of more frequent and violent bouts of volatility. The sub-advisor believes that there may opportunity for gains if recession indicators prompt central banks to loosen monetary policy. The sub-advisor remains cautious on the outlook for Canadian banks given a slowing Canadian housing market and possible resultant credit losses.

## Related Party Transactions

### Management and Administration Services

For each applicable series, the Fund paid management fees and administration fees to Counsel at the annual rates specified under *Series Information* in this report and as more fully described in the Simplified Prospectus. In return for the administration fees, Counsel pays all costs and expenses (other than certain specified fund costs) required to operate the Fund. See also *Management Fees*.

### Other Related Party Transactions

Other investment funds managed by Counsel (“Top Funds”) invest in Series O securities offered by the Fund on a prospectus-exempt basis in accordance with the investment objectives of those funds. Series Private Wealth securities are issued on a prospectus-exempt basis to investors in the IPC Private Wealth program offered by IPC Securities Corporation, an affiliate of Counsel. At September 30, 2019, Top Funds owned 85.7% of the Fund’s NAV and Series Private Wealth investors owned 5.8% of the Fund’s NAV. As of September 30, 2019, Counsel had not received notice of any large redemptions. All related party transactions are based on the NAV per security on each transaction day.

The Fund relied on standing instructions from the Counsel Funds Independent Review Committee (“IRC”) with regards to asset re-allocations.

## Management Fees

The Fund’s management fees were used by the Manager to pay for: costs of managing the investment portfolio; providing investment analysis and recommendations; making investment decisions; the purchase and sale of the investment portfolio; and providing other services. The Manager also used the management fees to fund commission payments and other compensation (collectively, “Distribution Related Payments”) paid to the dealers and brokers for securities of the Fund bought and held by investors.

The following dealers, who are affiliated with Counsel, may be entitled to Distribution Related Payments from Counsel on the same basis as unrelated registered brokers and dealers: IPC Securities Corporation, Investors Group Securities Inc., IPC Investment Corporation, Investors Group Financial Services Inc. and Quadrus Investment Services Ltd.

During the period, approximately 35% of the total management fee revenues received from all Counsel funds were used to fund Distribution Related Payments to registered dealers and brokers. In comparison, such Distribution Related Payments for the Fund represented 38% of the management fees paid. This amount is an average percentage of the management fees paid by all series. The actual percentage for each series may be higher or lower than the average depending on the level of trailing commissions and sales commissions paid for that series.

## Series Information

The Fund may issue an unlimited number of securities for each series. The number of issued and outstanding securities of each series is disclosed in *Financial Highlights*. <sup>2</sup> A negotiable advisory or asset-based fee (plus sales taxes) is payable by investors to their dealer(s) in connection with the securities held in this series. <sup>8</sup> Counsel may, at its discretion, waive or lower the management fee (either directly or indirectly) and/or administration fee payable by investors.

## Past Performance

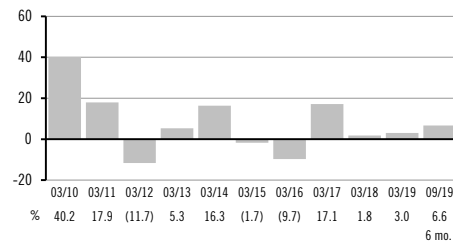
- In January 2010, the Fund began to pay an administration fee. In exchange, the Manager began to pay certain operating costs and expenses that had previously been paid by the Fund.

## Year-by-Year Returns

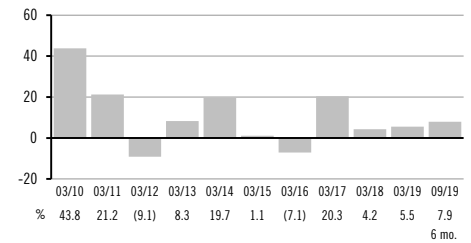
The bar chart shows how much an investment made on the first day of each financial year would have increased or decreased by the end of the respective periods. For the first year of a series, the percentage

shown will be the actual return of the series from its inception date, which can be found under *Series Information*. The chart illustrates how the Fund's performance has changed over time.

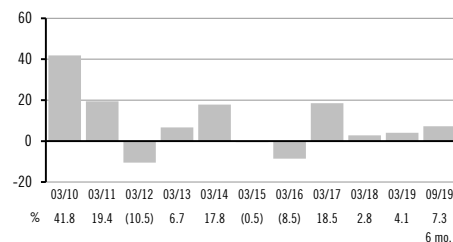

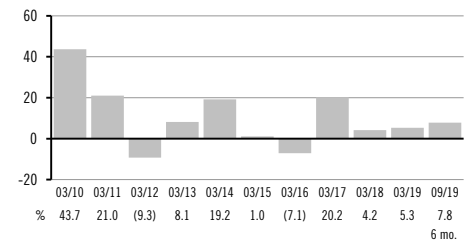

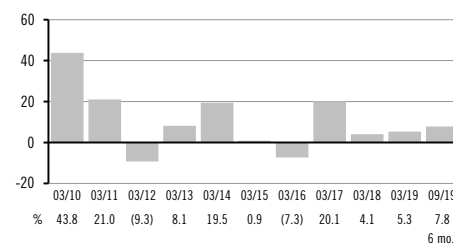
