Management Discussion of Fund Performance

June 8, 2021

This Management Discussion of Fund Performance presents the views of Counsel Portfolio Services Inc. ("Counsel") on the significant factors and developments during the year ended March 31, 2021 that have affected the Fund's performance and outlook. For information on the Fund's longer-term performance, please refer to the *Past Performance* section of the report.

In addition, net asset value (NAV) refers to the value of the Fund or a series, as calculated for transaction purposes, on which the discussion of Fund performance is based.

Investment Objective and Strategies

The Fund seeks long-term growth of capital by investing primarily in global equity securities with below average market capitalization. The Fund may also invest in mutual fund securities, equities and fixed income securities of issuers located anywhere in the world depending upon prevailing market conditions.

Risk

The risks of investing in the Fund remain as discussed in the Fund's Simplified Prospectus. The Fund is suitable for investors who: seek a global equity fund to hold as part of their portfolio; want a long-term investment; can handle the volatility of stock markets; and have a medium tolerance for risk.

Results of Operations

Investment Performance

The performance of the Fund's Series A securities is discussed below. The performance of all other series offered by the Fund is shown in the *Past Performance* section of this report. Where series returns differ, it is primarily because different levels of fees and expenses were charged to each series, or because securities of a series were not issued and outstanding for the entire reporting period. Please refer to the *Series Information* section of this report for the varying management and administration fees payable by series.

During the year, the Fund's Series A securities returned 72.17% (after deducting fees and expenses). This compares with a 36.01% return of the broad-based MSCI World Total Return Index and a 60.21% return of the mandate-specific MSCI World Small Cap Total Return Index. All index and series returns are calculated on a total

return basis in Canadian dollar terms. Investors cannot invest in an index without incurring fees, expenses, and commissions, none of which are reflected in the index returns.

Global small-capitalization stocks significantly outperformed large-capitalization stocks. Within the MSCI AC (All Country) World Small Cap (Net) Index, the Netherlands, India, and Norway were the strongest-performing countries while Peru, Kuwait and Egypt were the weakest. The Consumer Discretionary, Energy and Materials sectors were the strongest performers, while Utilities, Real Estate and Consumer Staples were the weakest. Canadian small-capitalization stocks significantly outperformed large-capitalization stocks. Within the S&P/TSX SmallCap Index, Energy, Industrials and Consumer Discretionary were the strongest sectors, while Healthcare, Real Estate and Utilities were the weakest.

The Fund outperformed the broad-based MSCI World Total Return Index. The broad-based index is designed to measure the performance of the overall developed large cap equity markets, whereas the Fund invests with a focus on small cap equities. Given the Fund's composition, the mandate-specific index provides a more meaningful comparison for relative performance.

The Fund's global ex. Canada mandate sub-advised by Wasatch outperformed the mandate-specific index primarily due to security selection within the Industrials, Financials, and Consumer Discretionary sectors and an overallocation to Information Technology.

The Fund's Canadian mandate, sub-advised by Mackenzie Investments, also contributed to overall outperformance as it returned 83.85%, although underperforming the S&P/TSX Small Cap Index, which returned 100.15%. Security selection within Industrials and Energy sector detracted from performance while being underweight Healthcare contributed.

During the year, the U.S. dollar ("USD") depreciated 10.87% against the Canadian dollar ("CAD"). As a result, the Fund's USD exposures detracted from returns. Selected hedging activities against the USD contributed relative to the unhedged indices with the Fund ending the period with a 37.5% target hedge.

The Euro ("EUR"), British Pound ("GBP") and Japanese Yen ("JPY") depreciated 5.12%, 0.69%, and 13.39% respectively against the CAD, detracting from the Fund's performance. Selected hedging activities against the EUR and GBP also contributed to relative performance with the Fund ending the period with a 50% target hedge on the EUR and 25% target hedge against the GBP.

Net Assets

The Fund's NAV increased by \$93.5 million, or 35.4%, to \$357.2 million as at March 31, 2021, from \$263.7 million at March 31, 2020. Of this increase, \$178.1 million was attributable to investment performance (after deducting fees and expenses) and partially offset by \$84.6 million of net redemptions.

Fees and Expenses

The Management Expense Ratio ("MER") for Series A of 2.47%, during the year ended March 31, 2021, was slightly lower than the MER of 2.51% for the year ended March 31, 2020. The MERs for all series (before and after waivers or absorptions, if any) are presented in the *Financial Highlights* section of this report.

Recent Developments

Governments worldwide have enacted various measures in seeking to combat the spread of the COVID-19 virus. These measures have led to significant volatility in equity markets and material disruption to businesses globally, resulting in an economic slowdown.

Ongoing uncertainty regarding the duration and long-term impact of the pandemic and the implementation of vaccination programs, as well as the efficacy of government and central bank monetary and fiscal interventions, may continue to affect the Fund's performance in future periods.

As uniquely eventful as the period was, Wasatch is increasingly optimistic due to the successful vaccine rollout in the U.K. where the Fund owns a number growth companies that are poised to perform well over the coming years of Brexit turmoil. The Canadian sub-advisor expects a strong recovery in global gross domestic product ("GDP") and corporate earnings in the second half of 2021, driven by the rollout of vaccines, continued fiscal stimulus and abundant central bank liquidity. In March 2021, consensus GDP growth and inflation forecasts for Canada both rose. The accelerating pace of vaccination led to expectations of deflation in 2021, while the U.S. fiscal stimulus package is expected to boost Canadian exports and investment spending.

The Fund ended the period with an 85% weighting in the global ex. Canada sleeve and a 15% weighting in the Canadian sleeve.

Effective February 24, 2021, Martin Taylor retired as a member of the Counsel Funds' Independent Review Committee.

Related Party Transactions

Management and Administration Services

For each applicable series, the Fund paid management fees and administration fees to Counsel at the annual rates specified under *Series Information* in this report and as more fully described in the Simplified Prospectus. In return for the administration fees, Counsel pays all costs and expenses (other than certain specified fund costs) required to operate the Fund. See also *Management Fees*.

Other Related Party Transactions

Other investment funds managed by Counsel ("Top Funds") invest in Series O securities offered by the Fund on a prospectus-exempt basis in accordance with the investment objectives of those funds. Series Private Wealth securities are issued on a prospectus-exempt basis to investors in discretionary managed account programs offered by IPC Securities Corporation, an affiliate of Counsel. As a result of these investments, the Fund is subject to large transaction risk as discussed in its Simplified Prospectus. Counsel manages this risk to reduce the possibility of any adverse effect on the Fund or on its investors, through such processes as requiring advance notice of large redemptions. At March 31, 2021, Top Funds owned 72.5% of the Fund's NAV and Series Private Wealth investors owned 19.7% of the Fund's NAV. As of March 31, 2021, Counsel had not received notice of any large redemptions. All related party transactions are based on the NAV per security on each transaction day.

The Fund relied on standing instructions from the Independent Review Committee with regards to asset re-allocations and the removal of the Invesco Canada Limited as a sub-advisor in April 2020.

Management Fees

The management fee for each applicable series is calculated and accrued daily as a percentage of its NAV. The Fund's management fees were used by the Manager to pay for: costs of managing the investment portfolio; providing investment analysis and recommendations; making investment decisions; the purchase and sale of the investment portfolio; and providing other services. The Manager also used the management fees to fund trailing commissions and other compensation (collectively, "Distribution Related Payments") paid to registered dealers and brokers whose clients invest in the Fund.

The following dealers, who are affiliated with Counsel, may be entitled to Distribution Related Payments from Counsel on the same basis as unrelated registered brokers and dealers: IPC Securities Corporation, Investors Group Securities Inc., IPC Investment Corporation, Investors Group Financial Services Inc. and Quadrus Investment Services Ltd.

During the year, approximately 33% of the total management fee revenues received from all Counsel funds were used to fund Distribution Related Payments to registered dealers and brokers. In comparison, such Distribution Related Payments for the Fund represented 40% of the management fees paid. This amount is an average percentage of the management fees paid by all series. The actual percentage for each series may be higher or lower than the average depending on the level of trailing commissions paid for that series. The higher proportion of Distribution Related Payments is primarily attributable to the higher proportion of retail investors in series which pay a trailer fee compared to other Counsel Funds.

Past Performance

The indicated rates of return are the historical annual compound total returns, including changes in NAV per security and assuming reinvestment of all distributions. They do not take into account sales, redemption, distribution or optional sales charges, management fees directly payable by investors or income taxes payable by any investor that would have reduced returns. Returns for each series primarily differ because fees and expenses vary for each series. Please refer to *Series Information* for further information. The past performance of the Fund is not necessarily an indication of how it will perform in the future.

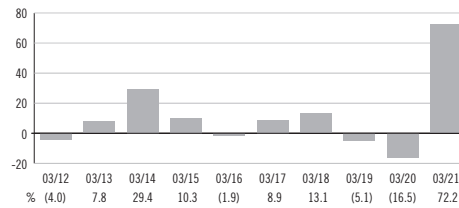

Year-by-Year Returns

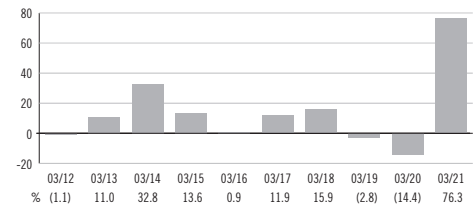
The bar chart shows how much an investment made on the first day of each financial year would have increased or decreased by the end of the respective periods. For the first year of a series, the percentage

shown will be the actual return of the series from its inception date, which can be found under *Series Information*. The chart illustrates how the Fund's performance has changed over time.

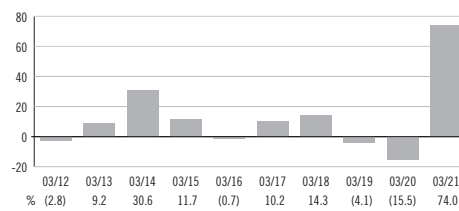

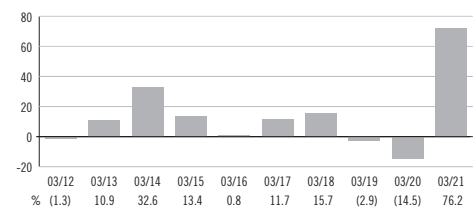

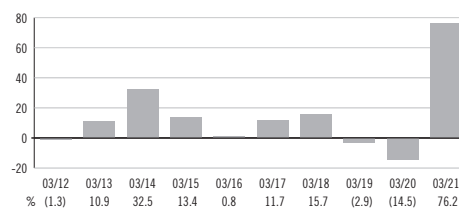
