Management Discussion of Fund Performance

November 11, 2021

This Management Discussion of Fund Performance presents the views of Counsel Portfolio Services Inc. (“Counsel”) on the significant factors and developments during the period ended September 30, 2021 that have affected the Fund’s performance and outlook. For information on the Fund’s longer-term performance, please refer to the *Past Performance* section of the report.

In addition, net asset value (NAV) refers to the value of the Fund or a series, as calculated for transaction purposes, on which the discussion of Fund performance is based.

Results of Operations

Investment Performance

The performance of the Fund’s Series A securities is discussed below. The performance of all other series offered by the Fund is shown in the *Past Performance* section of this report. Where series returns differ, it is primarily because different levels of fees and expenses were charged to each series, or because securities of a series were not issued and outstanding for the entire reporting period. Please refer to the *Series Information* section of this report for the varying management and administration fees payable by series.

During the six-month period, the Fund’s Series A securities returned 3.23% (after deducting fees and expenses). This compares with a 4.12% return of a blended benchmark comprised of 60% FTSE TMX Canada Bond Universe Total Return Index (returned 1.14%), 33.33% MSCI World Total Return Index (returned 8.59%) and 6.67% S&P/TSX Composite Index (returned 8.73%) (the “Blended Benchmark”). All index and series returns are calculated on a total return basis in Canadian dollar terms. Investors cannot invest in an index without incurring fees, expenses, and commissions, none of which are reflected in the index returns.

The period was characterized by rising commodity prices, supply chain issues and rolling economic interruptions worldwide due to the emergence of the COVID-19 Delta variant. Despite the largest monthly decline of 2021 in September, global equity markets ended the period higher. Accommodative

monetary and fiscal policies across Group of Ten (“G10”) countries supported economic recovery. A rebound in the prices of higher-risk assets, including high-yield bonds, was supported by demand, given more than US\$14 trillion of negative-yielding debt and increased confidence in a strong economic rebound. Generally, growth-oriented equities outperformed value-oriented equities during the period.

The Fund outperformed the broad-based FTSE TMX Canada Bond Universe Total Return Index. The broad-based index is comprised of Canadian fixed-income securities and has no exposure to equities, whereas the Fund invests in both equity and fixed-income mutual funds. Given the Fund’s composition, the Blended Benchmark provides a more meaningful comparison.

The Fund underperformed the Blended Benchmark due to an underweight allocation to U.S. equities, which outperformed based on leadership from the Information Technology sector. The Fund’s holding in Counsel U.S. Value underperformed based on allocation and security selection in the Consumer Discretionary and Energy sectors. The Fund’s holding in Counsel International Growth underperformed, in part due to holdings in China which were negatively impacted by a government crackdown on technology companies.

During the period, the U.S. dollar (“USD”) appreciated 0.75% against the Canadian dollar (“CAD”). As a result, the Fund’s USD exposures contributed to returns. Its underlying equity funds’ target hedge against the USD, which increased from 37.5% to 50% during the period, detracted relative to the unhedged Blended Benchmark. The Euro (“EUR”) and British Pound (“GBP”) depreciated 0.48% and 1.23% respectively against the CAD detracting from the Fund’s performance. Target hedges maintained throughout the period of 50% and 25% against the EUR and GBP respectively partially offset this impact. Additionally, the Japanese Yen (“JPY”) appreciated 0.21% against the CAD contributing to the Fund’s performance.

Net Assets

The Fund’s NAV declined by \$6.9 million, or 2.0%, to \$335.4 million as at September 30, 2021, from \$342.3 million at March 31, 2021. Of this decrease, \$19.6 million was attributable to net redemptions and partially offset by a \$12.7 million increase due to investment performance (after deducting fees and expenses).

Fees and Expenses

The Management Expense Ratio (“MER”) for Series A of 2.39%, during the period ended September 30, 2021, was slightly lower than the MER of 2.40% for the year ended March 31, 2021. The MERs for all series (before and after waivers or absorptions, if any) are presented in the *Financial Highlights* section of this report.

Recent Developments

Ongoing uncertainty regarding the duration and long-term impact of the COVID-19 pandemic and the implementation of vaccination programs, as well as the efficacy of government and central bank monetary and fiscal interventions, may continue to affect the Fund’s performance in future periods.

The Counsel portfolio management team believes that the economy is approaching mid-cycle, having passed the peak rate of expansion and policy accommodation, and therefore has more moderate expectations for growth. However, the team expects the trillions of dollars in excess savings accumulated over multiple lockdowns may offset this scenario by supporting increased consumer and business spending. In addition, many major central banks have begun tightening monetary policy and governments are decreasing fiscal support, which the team believes reduces the risk of persistent inflation. The team believes an environment of strong growth with inflation expectations under control is positive for riskier assets such as stocks.

Effective September 22, 2021, Atul Tiwari was appointed to the Counsel Funds’ Independent Review Committee.

The Fund remains tilted toward equities relative to its neutral weighting. Within the fixed income allocation, the Fund is overweight high yield bonds relative to its neutral weighting. Effective October 15, 2021, Counsel eliminated its hedges against foreign currencies in the underlying equity funds. Currency hedging is dynamic and may vary between 0-100% at our discretion based on our assessment of currency market conditions.

Related Party Transactions

Management and Administration Services

For each applicable series, the Fund paid management fees and administration fees to Counsel at the annual rates specified under *Series Information* in this report and as more fully described in the Simplified Prospectus. In return for the administration fees, Counsel pays all costs and expenses (other than certain specified fund costs) required to operate the Fund. See also *Management Fees*.

Other Related Party Transactions

The Fund did not rely on an approval, standing instruction, or positive recommendation from the Counsel Funds' Independent Review Committee ("IRC") with respect to any related party transactions.

Management Fees

The management fee for each applicable series is calculated and accrued daily as a percentage of its NAV. The Fund's management fees were used by the Manager to pay for: costs of managing the investment portfolio; providing investment analysis and recommendations; making investment decisions; the purchase and sale of the investment portfolio; and providing other services. The Manager also used the management fees to fund trailing commissions and other compensation (collectively, "Distribution Related Payments") paid to registered dealers and brokers whose clients invest in the Fund.

The following dealers, who are affiliated with Counsel, may be entitled to Distribution Related Payments from Counsel on the same basis as unrelated registered brokers and dealers: IPC Securities Corporation, Investors Group Securities Inc., IPC Investment Corporation, Investors Group Financial Services Inc. and Quadrus Investment Services Ltd.

During the period, approximately 33% of the total management fee revenues received from all Counsel funds were used to fund Distribution Related Payments to registered dealers and brokers. In comparison, such Distribution Related Payments for the Fund represented 35% of the management fees paid. This amount is an average percentage of the management fees paid by all series. The actual percentage for each series may be higher or lower than the average depending on the level of trailing commissions paid for that series.

Past Performance

The indicated rates of return are the historical annual compound total returns, including changes in NAV per security and assuming reinvestment of all distributions. They do not take into account sales, redemption, distribution or optional sales charges, management fees directly payable by investors or income taxes payable by any investor that would have reduced returns. Returns for each series primarily differ because fees and expenses vary for each series. Please refer to *Series Information* for further information. The past performance of the Fund is not necessarily an indication of how it will perform in the future.



Year-by-Year Returns


The bar chart shows how much an investment made on the first day of each financial year would have increased or decreased by the end of the respective periods. For the first year of a series, the percentage

shown will be the actual return of the series from its inception date, which can be found under *Series Information*. The chart illustrates how the Fund's performance has changed over time.




SERIES PRIVATE WEALTH








