Management Discussion of Fund Performance

November 11, 2021

This Management Discussion of Fund Performance presents the views of Counsel Portfolio Services Inc. (“Counsel”) on the significant factors and developments during the period ended September 30, 2021 that have affected the Fund’s performance and outlook. For information on the Fund’s longer-term performance, please refer to the *Past Performance* section of the report.

In addition, net asset value (NAV) refers to the value of the Fund or a series, as calculated for transaction purposes, on which the discussion of Fund performance is based.

Results of Operations

Investment Performance

The performance of the Fund’s Series A securities is discussed below. The performance of all other series offered by the Fund is shown in the *Past Performance* section of this report. Where series returns differ, it is primarily because different levels of fees and expenses were charged to each series, or because securities of a series were not issued and outstanding for the entire reporting period. Please refer to the *Series Information* section of this report for the varying management and administration fees payable by series.

During the six-month period, the Fund’s Series A securities returned 1.41% (after deducting fees and expenses). This compares with a 10.05% return of the broad-based S&P 500 Total Return Index and a 5.22% return of the style-based Russell 1000 Value Index. All index and series returns are calculated on a total return basis in Canadian dollar terms. Investors cannot invest in an index without incurring fees, expenses, and commissions, none of which are reflected in the index returns.

U.S. equity markets rose despite experiencing the worst monthly decline of 2021 in September. The U.S. 10-year Treasury bond rate trended lower early in the period, prompting a consolidation in value stocks, while large-capitalization growth stocks led markets higher. The emergence of the COVID-19 Delta variant and supply issues raised concerns of a slowdown in economic activity and the potential for higher-than-expected inflation. Within the Russell 1000 Value Index, Real Estate, Financials and Energy were the strongest sectors, while Information Technology, Industrials and Materials were the weakest.

The broad-based index is designed to measure the performance of the overall U.S. equity market, whereas the Fund invests with a focus on value-oriented equities. Given the Fund’s composition, the style-based index provides a more meaningful comparison for relative performance.

The Fund, which is managed based on a quantitative deep-value style, underperformed the broad-based index as the Growth-style outperformed the Value-style in the second and third quarters of 2021. This underperformance was not unexpected as the reflationary recovery coming into the first quarter of 2021 saw markets reward Value-style stocks, while subsequently reversing somewhat into the current reporting period. The Fund underperformed the style-based index primarily due to allocation and security-selection decisions to the Consumer Discretionary and Energy sectors.

During the period, the U.S. dollar (“USD”) appreciated 0.75% against the Canadian dollar (“CAD”). As a result, the Fund’s USD exposures contributed to returns. The target hedge against the USD, which increased from 37.5% to 50% during the period, detracted relative to the unhedged indices.

Net Assets

The Fund’s NAV declined by \$13.9 million, or 6.5%, to \$200.3 million as at September 30, 2021, from \$214.2 million at March 31, 2021. Of this decrease, \$19.9 million was attributable to net redemptions and partially offset by a \$6.0 million increase due to investment performance (after deducting fees and expenses).

Fees and Expenses

The Management Expense Ratio (“MER”) for Series A of 2.44%, during the period ended September 30, 2021, was slightly higher than the MER of 2.41% for the year ended March 31, 2021. The MERs for all series (before and after waivers or absorptions, if any) are presented in the *Financial Highlights* section of this report.

Recent Developments

Ongoing uncertainty regarding the duration and long-term impact of the COVID-19 pandemic and the implementation of vaccination programs, as well as the efficacy of government and central bank monetary and fiscal interventions, may continue to affect the Fund’s performance in future periods.

In terms of equity markets, particularly in value-oriented equities, the sub-advisor sees the delta variant as a pause ahead of stronger more durable global growth in the future. Value equities tend to be impacted by shifts in growth levels, often as businesses with reasonably high debts are more

reactive to positive growth shifts and sentiment in that direction. Some segments of value equity, such as banks and insurance sectors, are more directly rate sensitive. The sub-advisor believes there are opportunities for positive market outcomes as the next few years look well set up for continued growth and outperformance.

Effective September 22, 2021, Atul Tiwari was appointed to the Counsel Funds’ Independent Review Committee.

Effective October 15, 2021, Counsel eliminated the Fund’s hedge against the USD. Currency hedging is dynamic and may vary between 0-100% at our discretion based on our assessment of currency market conditions.

Related Party Transactions

Management and Administration Services

For each applicable series, the Fund paid management fees and administration fees to Counsel at the annual rates specified under *Series Information* in this report and as more fully described in the Simplified Prospectus. In return for the administration fees, Counsel pays all costs and expenses (other than certain specified fund costs) required to operate the Fund. See also *Management Fees*.

Other Related Party Transactions

Other investment funds managed by Counsel (“Top Funds”) invest in Series O securities offered by the Fund on a prospectus-exempt basis in accordance with the investment objectives of those funds. Series Private Wealth securities are issued on a prospectus-exempt basis to investors in discretionary managed account programs offered by IPC Securities Corporation, an affiliate of Counsel. As a result of these investments, the Fund is subject to large transaction risk as discussed in its Simplified Prospectus. Counsel manages this risk to reduce the possibility of any adverse effect on the Fund or on its investors, through such processes as requiring advance notice of large redemptions. At September 30, 2021, Top Funds owned 89.7% of the Fund’s NAV and Series Private Wealth investors owned 4.1% of the Fund’s NAV. As of September 30, 2021, Counsel had not received notice of any large redemptions. All related party transactions are based on the NAV per security on each transaction day.

The Fund did not rely on an approval, positive recommendation, or standing instruction from the Counsel Funds’ Independent Review Committee (“IRC”) with respect to any related party transactions.

Management Fees

The management fee for each applicable series is calculated and accrued daily as a percentage of its NAV. The Fund's management fees were used by the Manager to pay for: costs of managing the investment portfolio; providing investment analysis and recommendations; making investment decisions; the purchase and sale of the investment portfolio; and providing other services. The Manager also used the management fees to fund trailing commissions and other compensation (collectively, "Distribution Related Payments") paid to registered dealers and brokers whose clients invest in the Fund.

The following dealers, who are affiliated with Counsel, may be entitled to Distribution Related Payments from Counsel on the same basis as unrelated registered brokers and dealers: IPC Securities Corporation, Investors Group Securities Inc., IPC Investment Corporation, Investors Group Financial Services Inc. and Quadrus Investment Services Ltd.

During the period, approximately 33% of the total management fee revenues received from all Counsel funds were used to fund Distribution Related Payments to registered dealers and brokers. In comparison, such Distribution Related Payments for the Fund represented 36% of the management fees paid. This amount is an average percentage of the management fees paid by all series. The actual percentage for each series may be higher or lower than the average depending on the level of trailing commissions paid for that series. As Series E of this Fund pays lower management fees than Series A of most other Counsel Funds while paying the same trailer fee, Distribution Related Payments comprise a higher proportion of the Fund's management fee than the average for all Counsel Funds.

Past Performance

The indicated rates of return are the historical annual compound total returns, including changes in NAV per security and assuming reinvestment of all distributions. They do not take into account sales, redemption, distribution or optional sales charges, management fees directly payable by investors or income taxes payable by any investor that would have reduced returns. Returns for each series primarily differ because fees and expenses vary for each series. Please refer to *Series Information* for further information. The past performance of the Fund is not necessarily an indication of how it will perform in the future.



Year-by-Year Returns


The bar chart shows how much an investment made on the first day of each financial year would have increased or decreased by the end of the respective periods. For the first year of a series, the percentage

shown will be the actual return of the series from its inception date, which can be found under *Series Information*. The chart illustrates how the Fund's performance has changed over time.








